ALL STAKES ARE WALKING STAKES. All stakes single course without bird field. Liberated quail used in all stakes, except puppy stakes. Shotguns with blank shells are not permitted in any stake. **Open Gun Dog and Amateur Gun Dog are Retrieving stakes** with a call back for a retrieve. A blank cartridge **WILL NOT** be fired in the Puppy Stakes.

Only AKC approved tracking collars will be permitted at this trial.
