TOWN BOARD MEETING AGENDA
June 24th, 2021

On June 24th, 2021, the Town Board of the Town of Elbridge held their regular board meeting. Supervisor Vern Richardson called the meeting to order at 7:00 PM, and led the Pledge of Allegiance.

PRESENT: Supervisor Vern Richardson, Councilor Todd Platten, Councilor Floyd Duger

OTHERS PRESENT: Attorney Timothy Frateschi, Code Officer Howard Tanner, Historian Jason Parkman, Town Clerk Danielle Karlik, Salem Lahood, and two other guests.

ADOPT MINUTES: On a motion by Councilor Duger, seconded by Councilor Platten, the minutes from June 10th, 2021 were approved.

MOTION TO PAY BILLS: On a motion by Councilor Platten, seconded by Councilor Duger, General Bills Abstract #06, Vouchers #209-245, in the amount of \$50,611.22, and Highway Bills, Abstract #06, Vouchers #1121-1139, in the amount of \$27,388.58 were approved to be paid with a total disbursement of \$77,999.80.

GUESTS: Salem Richard Lahood from the Silo 31 Event Center spoke on the proposed PPD project for the property. There are various opportunities presented for future use of the property.

OLD BUSINESS: Councilor Platten inquired about the water bond. Was a bid packet sent to Lyons Bank in Jordon. Packets were sent out to Lyons and M&T local banks. Budget sheets should be dispersed in July.

NEW BUSINESS: There is some concern about pooling water in the Community Center pavilion. Eve troughs will be installed. It was suggested that a drain be drilled and installed.

The senior programs are going well. Lunches are now over 9,100, and it is the hope that face to face lunches will be back by August. Coffee meetings are up to 40 people and the time has been moved from noon to 11:00 AM.

Highway has been busy with various projects.

Councilor Platten: The Environmental Commission met this week. They would like to plant trees along the Route 5 corridor. This was discussed among the Town Board and Town Attorney. It was determined that planting trees on private property could bring about several issues. The matter will be discussed further at a later date. It is understood that the Environmental Commission is enthusiastic to conduct projects, and other avenues will be looked into.

Supervisor Richardson: Water surveys are continuing around the Villages and Town. Sewer meeting will be continuing. There is some concern over the cost to residents with added projects.

Discussion in regards to a new building are still ongoing with several entities. Once certain parameters are obtained Barton and Loguidice can be approached in regards to engineering.

ADJOURNMENT: One a motion by Councilor Platten, seconded by Councilor Duger, the Elbridge Town Board meeting was adjourned at 7:56 PM.
