TOWN OF ELBRIDGE TOWN BOARD PUBLIC HEARING & MEETING MARCH 12th, 2020

The Town Board of the Town of Elbridge met on Thursday, March 12th, 2020 to hold a Public Hearing and conduct their regular meeting at 7PM, at the Town municipal Building, 5 Rte. 31, Jordan, NY.

Supervisor Vern Richardson called the meeting to order at 7PM and led the Pledge of Allegiance.

PRESENT: Councilor Doug Blumer, Councilor Floyd Duger, Councilor Mike Caron, Councilor Todd Platten, and Supervisor Vern Richardson.

OTHERS PRESENT: Melissa Clark of Abundant Solar, Code Officer Howard Tanner, Highway Superintendent Jim White, and Clerk Deb Stapleton

PUBLIC HEARING: The Town Board of the Town of Elbridge, at their meeting held on February 13th, 2020, called for a Public Hearing to be held on March 12th at 7PM at the Town Hall, 5 Rte. 31. Jordan, NY, the purpose of which is to consider the amended as amended readoption of Chapter 30 of the Town's Municipal Code. Public Hearing notice was published in the Syracuse Post Standard on February 27th, 2020, posted at the Jordan and Elbridge Post Offices, M&T Bank, Jordan Lyons Bank, and at the Town Hall.

<u>Supervisor Richardson</u>: Does anyone wish to speak in favor of this amended and as amended readoption of Chapter 30? Councilor Blumer said the Elbridge Planning board resolved to support the amended Chapter 30.
