The Town Board of the Town of Elbridge met on March 26th, 2020, at the Town municipal Building, at 5 Rte. 31, Jordan, NY at 7PM to conduct their regular meeting. Due to the Corona Virus Pandemic, the meeting was closed to the public, and minutes will be made available.
