1. BUYER REPRESENTATIONS

The Buyer affirms that they are purchasing this kitten for themselves and are not acting as an intermediary, agent, or broker for any other person or entity.

2. HEALTH STATUS AT TIME OF SALE

The Breeder certifies that at the time of sale the kitten is in good health and has:

- Received two (2) FVRCP vaccinations
- Been dewormed
- Been examined by a licensed veterinarian
- Been microchipped (unless otherwise requested)
- Been Spayed or Neutered

The Breeder further certifies that the kitten's parents have been genetically screened and that the kitten is not a carrier of Progressive Retinal Atrophy (PRA) or Pyruvate Kinase Deficiency (PK-def).

3. BUYER VETERINARY EXAM

The Buyer agrees to have the kitten examined by a licensed veterinarian within seventy-two (72) hours of taking possession. Failure to do so voids all health guarantees.

4. HEALTH GUARANTEES

A. Congenital Defects & Genetic Disease

The kitten is guaranteed to be free from congenital defects and genetic disease for a period of two (2) years from the date of sale. Diagnosis must be confirmed by a licensed veterinarian, and full medical records must be provided. A replacement kitten of equal value will be provided at the Breeder's earliest availability. No cash refunds.

B. Hypertrophic Cardiomyopathy (HCM)

The kitten is guaranteed against HCM for two (2) years from the date of sale, provided diagnosis is positive (not equivocal) and made by a board-certified veterinary cardiologist. Full cardiology report required. Replacement kitten of equal quality when available.

5. CARE REQUIREMENTS

The Buyer agrees to provide proper lifetime care including:

- Routine veterinary care and vaccinations (excluding FeLV)

- High-quality nutrition
- Clean, safe indoor living environment
- No cage confinement

6. PROHIBITED PRACTICES

- Declawing is strictly prohibited and voids all health guarantees
- The kitten shall never be allowed to roam freely outdoors
- Catio enclosures and harnesses are permitted

7. DEPOSIT & PAYMENT TERMS

All deposits are non-refundable if the Buyer cancels. If the Breeder cannot provide the kitten, the deposit will be refunded. Once the cat/kitten leaves our cattery and in the buyers possession, buyer is responsible for all costs and expenses pertaining to the cat/kitten including veterinary care.

8. RETURN & REHOMING POLICY

If the Buyer can no longer care for the kitten, the Breeder must be contacted first. If the breeder cannot take the cat/kitten back due to factors like distance they will help find suitable placement or give final approval of a placement found by the buyer. If the Buyer fails to do so and legal action is required, the Buyer is responsible for all legal fees. This policy helps ensure that our kittens produced do not end up in animal shelters.

9. NON-DISPARAGEMENT

Any disputes shall be handled privately and not posted publicly on social media, forums, or websites.

10. GOVERNING LAW, VENUE & LEGAL FEES

This Agreement shall be governed by the laws of the State of Maine.

Any legal action arising from this Agreement shall be filed exclusively in the State of Maine. The Buyer agrees to be solely responsible for all legal fees, court costs, and attorney's fees incurred by the Breeder, whether or not the Breeder prevails.

11. BREACH & ENFORCEMENT

Breach of any provision renders this Agreement void and the Breeder reserves the right to determine the disposition of the kitten, including reclaiming possession.

12. ENTIRE AGREEMENT

This Agreement constitutes the entire understanding between the parties.
