In exercise of the powers conferred in G.O.Ms.No.457,
Edn.dt.24.3.88, the Director of School Education is
pleased to sanction the upgradation of Sacred Heart Matriculation
School, Kodungaiyur, Madras 51 into Higher Secondary School
subject to the following conditions: during 1995-96

CONDITIONS.

1. The minimum strength in Std. XI should be not less than 30 in each class.
2. Adequate accommodation and sanitary facilities should be provided for the students.
3. Adequate equipments and Laboratory facilities should be provided.
4. Qualified teachers should be appointed as per G.O.Ms.No. 720, Edn. dt.28.4.81 and
5. The school should offer Vocational Courses also.
6. 5 Acres of land for play area should be provided.

The management is informed that the rules relating to the grant of Recognition to private Higher Secondary Schools have been issued in G.O.Ms.No.587, Edn. dt.22.3.78 and they are requested to go through these

conditions and give the written consent in clear terms that they will abide by the rules and conditions laid down by the department. Only eligible students should be admitted in Std.XI.

The details of the course, number of students, number of subjects to be offered, number of working days, allocation of periods, etc. have been published in the Tamil Nadu Government Gazetted dated 17.5.78 and 24.5.78. Copies of which can be obtained from the Government Publication Department, Anna Salai, Madras-2.

The Chief Educational Officer, Madras 15
may be consulted for any further guidance particulars
regarding the groups to be offered from amongst the approved
combination of subjects of general education and the
subjects under the vocational education and also for the
list of science equipment and vocational equipment
required for teaching the Higher Secondary Classes.

The management will apply to the Director of School Education in the prescribed form from the grant of recognition supported by full particulars and evidence.
