 - SEMA reached out to EMD (John?) and he said there were no unmet needs; however, some voluntary agencies know there are still needs.
 - Going to wait a little longer before requesting survivor data from FEMA (there is a formal process for this).
 - Renee (KDEM) brought up FEMA's VALOR program and wondered if anyone had looked into it.
