Our Southern Indiana RDA Urges Participation in READI Arts & Culture Webinar *IEDC hosting Feb. 10 informational session on arts and culture funding*

Jeffersonville, Ind. — Our Southern Indiana Regional Development Authority (RDA) is encouraging artists, cultural organizations, nonprofits, local governments, and community partners across Southern Indiana to participate in an upcoming informational webinar focused on the READI Arts & Culture Initiative.

The webinar will be hosted by the Indiana Economic Development Corporation (IEDC) on Tuesday, February 10, at 3 PM. The READI Arts & Culture Initiative is being advanced under the leadership of Governor Mike Braun in partnership with the Indiana Arts Commission. The session will provide an overview of the READI Arts & Culture grants program, including program goals, eligibility, application requirements, and evaluation criteria, and is intended to help potential applicants prepare projects for future funding opportunities.

“This initiative aligns directly with the work our region has been doing to elevate arts and culture as an economic driver,” said RDA Chair Dana Huber. “Southern Indiana has a strong foundation of creative assets — from historic downtowns and cultural districts to music, festivals, and public art and spaces. This program offers a path to turn those strengths into long-term regional impact.”

The Indiana Economic Development Corporation anticipates awarding READI 2.0 Arts & Culture Initiative funding to select projects across the state beginning in 2026.

The Our Southern Indiana RDA is sharing this opportunity as part of its role as the regional convener for READI efforts across Clark, Floyd, Jefferson, Scott, and Washington counties. The webinar builds on recent regional planning and engagement that emphasize arts and culture as essential components of economic development, tourism, talent attraction, and quality of place throughout Southern Indiana.

The webinar is open to both established organizations and emerging projects interested in learning more about the READI Arts & Culture Initiative. A recording of the session will be posted at IndianaREADI.com following the event, and additional documentation related to the application process will be shared afterward.
