It is important to note that <u>READI 1 FUNDS</u> used for these projects are <u>FEDERAL FUNDS</u>. All applicable Federal statutes must be followed and strict internal control processes are required to ensure the funds are spent in accordance with Federal guidelines and that all funds disbursed have been approved by the RDA Board of Directors and the IEDC.

It will take an estimated <u>45 days</u> from the time River Hills receives a disbursement request from the project leads until funds are received by the RDA from the IEDC. In order to issue payments of READI 1 FUNDS in the most efficient and timely way possible, a timeline schedule has been adopted and is shown below.

Attached is a list of required documents to be submitted with each disbursement request. It is <a href="IMPERATIVE">IMPERATIVE</a> that <a href="COMPLETE CLAIM INFORMATION">COMPLETE CLAIM INFORMATION</a> be submitted by the Project Leads to River Hills on or before the deadline date. Since there are several approval processes from the time of claim submission to River Hills until funds are released by the IEDC, it is <a href="STRONGLY ADVISED">STRONGLY ADVISED</a> that Project Leads implement their own internal policy for timely processing of vendor invoices and strict adherence to the submission schedule.
