 To produce theatrical programs as an educational tool for the purpose of alleviating negative issues faced by older Americans.

**28** Our major program activity during 2022 was to produce a total of 10 live performances of Plays with Purpose, by seniors for seniors, with free admission. A total of 1,558 seniors were educated with tips to protect their well-being through attending or participating as volunteers in these activities. SAGES' unique use of live theater for elder education had amazing results. The breakdown of the 1,558 seniors served is 1,360 senior guests formed audiences; 83 on-site senior volunteers composed the cast, crew, and ushers; 15 off-site senior volunteers posted notices online, distributed printed flyers or stuffed good bags for distribution; and an additional 100 senior guests attended our speaking engagements about these Plays with Purpose. SAGES' Spring season debuted a new theme in the comedy play Deal Maker. This play raises awareness on safe driving and the signs of impairment that indicate it's time to surrender a drivers' license. Tips within the script include safety measures for drivers and their vehicles and alternatives to driving that help maintain a degree of independence. A Q&A session with our partner agency, Florida Highway Patrol, concluded the productions.

American Sign Language Interpreters (ASL) "signed" our play Phoney Baloney so guests who are deaf could still enjoy the play and learn the scam prevention tips presented on stage. And Denying Gravity, on fall prevention was performed entirely in Spanish to benefit the Hispanic community to protect themselves from the leading cause of injury and death for older adults. These plays were featured in our Fall season.

At the end of 8 weeks, their creation is presented as an event spotlighting the theme at their center. There were three successful presentations at the participating community centers. The program is being tweaked into the simplest format for seniors to conduct the program with minimal oversight.
