1. CALL TO ORDER

- House at the main entrance, which is not part of the HOA community, will continue to be reported to the city for the number of vehicles and trash left outside this home.

- **f. Pond Aerators** Previous estimates were expensive and could cost between \$1,000 \$3,000 for each pond. We will be looking into re-evaluating the cost and checking for solar or electrical options for these aerators. More to follow.
