Fern Brisco – The traffic located on Halcyon and Brisco is too much, something needs to be done.

Mark McGuire-Urgent Issue on Strand Way the street needs to be replaced and the sand needs to be removed. He provided a response from the Department of Parks and Recreation along with photos of neighbors who could not get out of their homes due to sand blocking all exits and entrance to the homes.

Charles Varni- He is the President of the Oceano Community Services District and reported the first meeting of OCSD went well.. Wants to see clean-up of the Card Room and the Tamale Place.
