### Facts found:

- 1. Race 2 of the Inside Project Brass Monkey Series was on Saturday 18 May 2024
- 2. Wind direction from south and approximately 10 knots
- 3. Leg 1 of the course was from start to R3
- 4. Pompette sailing on starboard tack
- 5. Pompette SOG high 5 to low 6 knots
- 6. How Bizarre sailing on port tack
- 7. How Bizarre SOG approximately 6.5 knots
- 8. Matador sailing on a starboard tack to leeward and just ahead of Pompette
- 9. How Bizarre crossed over in front of Matador with How Bizarre still on port tack
- 10. How Bizzarre approached Pompette
- 11. Pompette hailed starboard
- 12. How Bizarre within approximately one boat length tacked onto port tack
- 13. Pompette took avoiding action and luffed to avoid a collision with How Bizarre
- 14. There was no contact between Pompette and How Bizarre

## Conclusion & Rules:

Pompette had a reasonable apprehension that a collision was imminent and took avoiding action.

How Bizarre has breached Rule 10 by causing Pompette to take that avoiding action.
