# RECORD OF PROCEDINGS WINDHAM TOWNSHIP October 3, 2024

Windham Township Board of Trustees met for their regular session on October 3, 2024 at 6:00 PM, Trustees Dan Burns, Brian Miller, Rich Gano and Fiscal Officer, Casey M Timmons were present. All board members received their monthly financial packets.

#### 2024-52

Brian Miller moved to approve September minutes, Dan Burns seconded, Brian Miller and Dan Burns voting yes, Rich Gano abstained, motion carried.

#### 2024-53

Brian Miller moved to approve September Expenditures, Dan Burns seconded, Brian Miller and Dan Burns voting yes, Rich Gano abstained, motion carried.

Troy Rhoads from Ohio Edison and is our point of contact for all our power needs.

He spoke about the recent storms and how he works through EMA. Rural areas are the last to get powers. He encourages residents to go online to add texting on their website to get updates and alerts. He talked about the Ohio Edison easements and how they at the top of the trees. When street lights are not inoperable, it is the townships responsibility to contact Ohio Edison.

Mr. Rhodes is working on an LED street light conversion project. We currently have 23 street lights within the Windham Township. The conversion of the street lights to LED will help to conserve energy and cut costs. Option 1, pay the up-front cost of \$4807, Option 2 is making a monthly payment of \$102.12 for 60 months (\$6,127.20 total costs) or Option 3 to replace on failure. The replace on failure could take many years.

The trustees discussed using the Nopec fund or ARP funds.

#### 2024-54

Rich Gano moved to approve option 1 (pay up-front costs of \$4807) of the Ohio Edison contract using the ARP money, Dan Burns seconded, all voting yes, motion carried.

### Zoning:

1. 9645 Shanks down Road permit

- 2. Dan Morganti still moving slowly on the 9092 State Route 303 property.
- 3. The zoning commission sent an email:

Discussed marijuana resolution language. As soon as we receive back from Regional Planning, we will set a public hearing and get it posted in the newspaper. Regional Planning board meeting is set for October 9. We are hoping to get approval on the 10th and run the newspaper add so that we can have the hearing as soon as possible.

Zoning board is requesting the trustees add to the Zoning Inspector job description to attend zoning meetings. Our goal is to improve communication and collaboration. The board was discussing the status of two open violations (Bryant Rd. – excessive automobiles at one and excessive junk at another) and felt this would be a good example of keeping updated with the zoning inspector. Other examples mentioned were just seeing if there were any opportunities for questions or clarifications from both the board and the inspector.

The next zoning commission meeting is October 17.

4. The trustees discussed the email with Jake Sweet. Jake said he can go to their meetings as his schedule allowed. Rich Gano suggested that Jake email the trustees board an update before their monthly meetings in place of attending two meetings a month.

Dan Burns moved to appoint Trisha Kendrick as the newest member of the BZA, Rich Gano seconded, all voting yes, motion carried.
