Ryan Shackelford was at the meeting to discuss the progress on the tornado clean up in the township and to asked the trustees to name a trustee to the donation coordination team (DCT). The donation fund has been established with the Portage Foundation and has set their first meeting for July 8th. At 6pm at the township hall. The purpose of the meeting is to determine who would be members on the board. At this time, residents are still struggling with their insurance companies. Ryan asked the board about other community members who would be good representatives to also be on the DCT board. Ryan also stressed that only one trustee should be appointed to the board to avoid having to advertise as a public meeting. The applications given to all residents affected contain sensitive information that should not be made public.

Portage Fund Windham Tornado currently has a total of \$13,927 in donations.

- 3. There was discussion about the Mrs. Raco's daughter stone that is placed in the new cemetery. Mrs. Raco would like to have the stone moved into the new cemetery.

Fire District:

- 1. Dan Burns is discussing on purchasing a new ambulance but funds are so tight. Current ambulance is a 2006.
- 2. Chief got a raise
- 3. Jaws of life purchased through BWC grant. Rich Gano had questions about the matching money if they have such a tight budget.
- 4. Brian Miller suggested that the fire board needs to look into setting uo a large equipment fund to purchase an ambulance. Dan Burns said that it is not an option since the budget is so tight.
- 5. Rich Gano said he is still looking into a tornado siren for the township. He reached out to David Joyce's office.

New Business:

Historical Society has a grant to do some work on the township green and place a new plaque on the time capsule.

There was discussion on the NOPEC grant money. We have \$9400 in grants with \$2,097 to be spent by November 30, 2024.

ARPA Funds need to obligated before the end of the year.
