#### 2023-45

Dan Burns moved to approve September minutes Rich Gano seconded all voting yes motion carried.

#### Roads:

## Zoning:

Substandard lots-nothing new for the zoning commission. There was no zoning commission meeting due to not enough members. The trustees are discussion on how to move forward.

### 2023-47

Rich Gano moved to make the following zoning resolution change regarding substandard lots and the 8-foot side yard setback by amending Section 2.12 G, Dan Burns seconded all voting yes, motion carried.

Section 2.12

G. **Substandard Lot**: Any lot that was platted prior to the enactment of this Resolution, that does not meet the requirements of this Resolution for yards, or other open space, may be utilized for single residence purposes, provided the necessary requirements for sanitary sewage facilities and water as established by the responsible health authority can be safely accommodated. The purpose of this provision is to permit utilization of recorded lots, which lack adequate width, depth, or area so long as reasonable living standards can be maintained.

In no case shall the side yard setback be less than 8 feet.

9092 St Rt 303, Windham Ohio 44288 Parcel # 40-045-00-009-009 status Rich visited the home. The property is in really bad shape. He had a hard time seeing the back of the property and obtained photos for the prosecutor.

Furnace is done. Yellow Jacket heating and Cooling LLC tested the sump pump in the basement and said that we need to get a sump pump to handle the water that gets into the basement during rains. Dan Burns to purchase one after the meeting.

## New Business:

Solar Farm. We received an email from Brett Bencze from the prosecutor's office. As per R.C. 519.213, a township has the authority through 519.02 to 519.25 to confer power on a board of trustees or board of zoning appeals with respect to the location, erection, construction, reconstruction, change, alteration, maintenance, removal, use or enlargement of any small wind farm or solar facility. A small solar facility being a facility that produces less than 50 megawatts. This section allows the township to create zoning regulations with respect to the above, and for referrals to the board of zoning appeals to make any further determinations or conditions.

The trustee had so discussion on this matter and will look into this further.
