- The two men took turns raping her while the other held the camera and traded back and forth. This accomplice is under investigation by the Harris County District Attorneys Office
- He has been with the Mealer campaign since the beginning and is still with her campaign as of May 11, 2022

His trial starts November; the victim is suing both rapists in civil court.

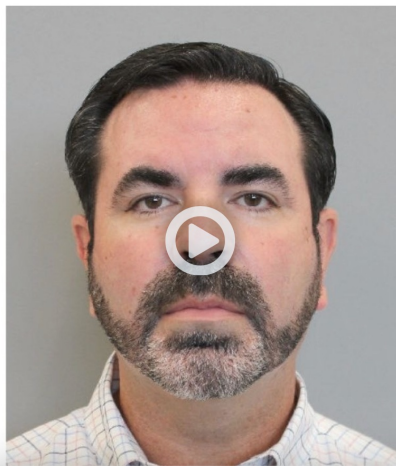
