NAIL TECHNICIAN COURSE OUTLINE 450 HOURS,13 WEEKS

COURSE DESCRIPTION

The curriculum involves 450 hours that are required by Kentucky State for the Nail Technician course. The course includes extensive instruction and practical experience in, the basics and general science in nails, their disorders and growth, artificial nail application, nail care and business ethics. You will also be taught sanitation, quality customer service, personal appearances and hygiene, personal motivation and development, positive attitude, state laws and regulations, safety and sanitation, salon types, and job interviewing.

GOALS AND OBJECTIVES

- 1. To provide a quality educational system to prepare each student to pass the state board examination. That quality system includes providing an outstanding facility, experienced instructors, and the curriculum developed through years of experiences and expertise.
- To train and graduate students who are prepared, confident, and excited to enter a successful career within the salon and beauty industry.
- 3. Practice general safety, sanitation, disinfection and sterilization.
- 4. Professionalism and providing the best customer service.

MEASURABLE PERFORMANCE OBJECTIVES

- 1. Received the required number of clock hours of training.
- 2. Complete and receive passing grades on all practical graduation requirements and projects to include examinations both practical and theory.
- 3. Satisfactory pass final written and practical exam.
- 4. Receive a graduation certificate.
- 5. Pass state board exam.

INSTRUCTIONAL TECHNIQUES AND METHODS

The 450-hour education is provided through a set of learning steps which address specific tasks necessary for state board preparation, graduation and job entry levels for a Nail Technician course. Clinic equipment, implements and products are comparable to those used in the industry. Each student will receive instructions that relates to the performance of useful, creative, and productive career-oriented activities. The course is presented through well-developed lesson plans that reflect the latest educational methods. Subjects are presented by means of lecture, demonstration and student participation. Audiovisual aids, guest speakers, field trips and other related learning methods are used in the course.

KENTUCKY STATE LAW REQUIREMENTS

Kentucky State law requires that students have 450 clock hours of training and be graduated from a licensed cosmetology school to qualify for initial cosmetology license. Following graduation, students are required to take a state board practical and written examination before receiving their Kentucky cosmetology license. This is a protected license, and it must be renewed every year. The state board gives these exams and there is a charge.

INDUSTRY REQUIREMENTS

Students interested in pursuing a career in nails should:

- 1. File, buff, clip, clean an apply polish and or artificial nails while using various tools including your hands.
- 2. Mix and apply a variety of chemicals.
- 3. Affectively communicate with clients, staff ,and instructors and demonstrate skills and interacting with customers.
- 4. Keep aware of the latest fashions and nail techniques.
- 5. Make a strong commitment to your education.
- 6. Be aware that the work can be physically demanding because of long hours standing and using your hands at shoulder level.

STATE LICENSING DISCLAIMER

The state may refuse to grant a license if a student has been convicted of a crime; committed any act involving dishonesty, fraud or deceit; or committed any act that's, if convicted by a licentiate of the business or profession in question, would be grounds for the Kentucky State board of hairdressers and cosmetology to deny licensure. The Kentucky State board of hairdressers and cosmetology denies licensors on the grounds that the applicants knowingly made a false statement of fact required to be revealed in the application for such license. Students who are not U.S. citizens or who do not have documented it authority to work in the United States will be eligible to apply to take the state licensure examination.
