## **BRAIDING COURSE OUTLINE 4 to 8 weeks (DOES NOT REQUIRE A LICENSE)**

### **COURSE DESCRIPTION**

The curriculum involves 4 to 8 weeks of extensive instruction and practical experience in the basics and general science of hair care, all braiding techniques and styles, neatness in partings and the finish look and business ethics. You will also be taught sanitation, quality customer service, personal appearances and hygiene, personal motivation and development, positive attitude, state laws and regulations, safety and sanitation, salon types, and job interviewing.

### **GOALS AND OBJECTIVES**

1. To provide a quality educational system to prepare each student to pass the certification of completion. That quality system includes providing an outstanding facility, experienced instructors, and the curriculum developed through years of experiences and expertise.
2. To train and graduate students who are prepared, confident, and excited to enter a successful career within the salon and beauty industry.
3. Practice general safety, sanitation, disinfection and sterilization.
4. Professionalism and providing the best customer service.

### **MEASURABLE PERFORMANCE OBJECTIVES**

1. Received the required number of clock days of training.
2. Complete and receive passing grades on all practical graduation requirements and projects to include examinations both practical and theory.
3. Satisfactory pass final completion practical exam of 4 models.
4. Receive a graduation certificate.

### **INSTRUCTIONAL TECHNIQUES AND METHODS**

The 4 to 8 weeks education is provided through a set of learning steps which address specific tasks necessary to establish a successful career in braiding and knowledge in Clinic equipment, implements and products are comparable to those used in the industry. Each student will receive instructions that relates to the performance of useful, creative, and productive career-oriented activities. The course is presented through well-developed lesson plans that reflect the latest educational methods. Subjects are presented by means of lecture, demonstration, and student participation. Audiovisual aids, guest speakers, field trips and other related learning methods are used in the course.

### **KENTUCKY STATE LAW REQUIREMENTS**

Kentucky State law does not require a Braider to obtain a license to practiced but they must abide by the rules. ### **INDUSTRY REQUIREMENTS**

**Students interested in pursuing a career in cosmetology should:**

1. Develop finger dexterity and a sense of form and artistry.

3. Keep aware of the latest fashions and beauty techniques.
4. Make a strong commitment to your education.
5. Be aware that the work can be physically demanding because of long hours standing and using your hands at shoulder level.

### **STATE LICENSING DISCLAIMER**

The state may refuse to grant a license if a student has been convicted of a crime; committed any act involving dishonesty, fraud or deceit; or committed any act that's, if convicted by a licentiate of the business or profession in question, would be grounds for the Kentucky State board of hairdressers and cosmetology to deny licensure. The Kentucky State board of hairdressers and cosmetology denies licensors on the grounds that the applicants knowingly made a false statement of fact required to be revealed in the application for such license. Students who are not U.S. citizens or who do not have documented it authority to work in the United States will be eligible to apply to take the state licensure examination.
