#### STUDENT ORIENTATION

#### ADMISSION REQUIREMENTS

A student must meet the state age requirement (16) and submit the following (if applicable)

- A copy of your states federal issued photo identification.
- 2 Passport photo taken within 30 days of submission of application
- Provide a copy of high school diploma, or its equivalent.
- A General Educational Development (GED) Diploma
- Results from the test for Adult Basic Education indicating a score equivalent to the successful completion of the 12th grade of high school
- May have to complete an Admissions assessment. (transfer student)
- Pay required registration fee and permit fee
- Complete and Enrollment Package
- Students applying for the Educator Training Program Must meet state enrollment requirements.
- Out of State transfers must have proper paperwork submitted to state and school that meet state requirements. (hours to be transferred from the state that governs the outside state)
- Apprentice Instructor: must provide a copy of a valid and current Kentucky cosmetology license

### ADDITIONAL ADMISSION INFORMATION

This school may accept appropriate credit from other licensed schools for previous education. This school does NOT guarantee the transferability of its credits to another institution unless there is a written agreement with the institution. Official transcripts are required prior to any enrollment along with the completion of any state transfer requirements (if applicable). Proficiency examinations may be used to determine the appropriate entry point in the curriculum based on the state requirements. The school will NOT make adjustments to recognize a student's prior education once the student has started at Bailey's Institution of Beauty.

The school maintains cumulative educational records in the accordance with all applicable federal, state, an accreditation regulation. See your school director for exact record retention length.

All courses are taught in English. Textbooks and course materials are only offered in the English language.

Bailey's Institution of Beauty does NOT recruit students already attending or admitted to another school offering similar program of studies.

Providing false information for the purpose of gaining admission or access to financial assistance is a violation of law and could result in criminal prosecution as well as denial of admission or termination from school.

In addition to satisfying the requirement for a valid high school diploma or GE D certificate, an applicant must demonstrate the character, readiness and commitment to successfully complete the academic program for which admission is requested and to work affectively in the occupations for which the program provides training. Bailey's Institution of Beauty also will consider an applicant's statements and demeanor during the admissions and orientation process.
