Hereinafter known as "buyer"

This agreement pertains to the following puppy, pictured on page 3 of this agreement :

Puppy must be paid in full before or at the time buyer takes possession of the puppy. Seller can ship puppy via air (flight nanny) or ground transportation; buyer assumes all shipping costs. If shipping is used, all shipping costs must be paid prior to shipping.

If buyer wishes to flight nanny the puppy himself, buyer *must get approval from seller before* booking and paying for the flight.

If shipping is not used, seller will travel to a halfway point agreed upon by both parties for transfer of the puppy. Seller will travel up to 2 hours one-way at her own expense; after that, seller charges a \$200 delivery fee up to 4 hours one-way. Seller will not travel more than 4 hours one-way.

Your puppy will come current on all shots and de-wormings. Buyer will receive copies of all vaccinations, de-wormings and veterinary records of puppy.

Seller guarantees puppy to be sound and free of diseases for a period of 10 calendar days after sale. Buyer is required to take puppy to his/her veterinarian for a health checkup within 10 days or health guarantee is null and void. Buyer must also insure that the puppy will continue to receive the appropriate vaccinations including, but not limited to, distemper, parvo and de-wormings.

Buyer hereby covenants that he/she will have the puppy neutered or spayed at his/her expense no sooner than the age of 6 months, but no older than 2 years of age, unless buyer is purchasing full rights and intends to raise puppies. If the puppy is female, it will come into heat for the first time prior to the 2-year deadline, and buyer covenants to take every diligent precaution to keep the bitch separated in a sturdy pen or crate separated from all other male dogs until her cycle is ended.

Puppy comes with a one-year health guarantee against inherited (not caused by injury) eye and/or hip defects. If buyer suspects a defect, puppy must be examined by his/her veterinarian at buyer's expense. If an inherited defect is diagnosed, veterinarian must submit written documentation to seller within two weeks of diagnosis. Seller reserves the right to have her own veterinarian examine the documentation. In such a case,

buyer can either choose to keep the puppy, wherein he/she assumes all expenses involved in the puppy's care, or buyer can return the puppy to the seller and receive a 50% refund on purchase price, or buyer can return the puppy to the seller and receive a replacement puppy the next time one is available. This guarantee does not include accidental death, theft, or sickness other than what the contract specifies.

If, for any reason, buyer is no longer able to care for this puppy, buyer or buyer's heirs are asked to return it to the seller for re-homing. Buyer/buyer's heirs understands there will be no refund of the purchase price, but the dog will be guaranteed a good home. Buyer hereby covenants that she/he understands that under no circumstances is this puppy ever to be relinquished to a dog pound or surrender group, in the event it can no longer be cared for.
