Voting results will be posted on the Crestwood Village website as soon as the votes are tallied and certified. Results will also be posted at the Clubhouse on Tuesday, May 6th by noon.

Hello Everyone,

Bulk Trash Pick-Up

There will be a bulk trash pick-up on **Saturday**, **May 3**rd. 777 Sanitation, Inc. has advised that pick-up might be early in the morning, so items can be placed on the curb the evening prior.

Examples of items accepted for bulk pick-up:

- Carpet
- Mattresses and box-springs
- · Loveseats and recliners
- Refrigerators and BBQ grills
- Small water heaters
- Window A/C units (must be free of Freon)
- Light patio furniture
- Televisions (5" 100")
- Light construction debris
- Lawn mowers (must be free of oil and fuel)

Solicitation in Our Community

We want to address a growing concern that has come to our attention regarding unsolicited visitors in our community. Management has received numerous calls about contractors knocking on residents' doors. We want to remind everyone to please not open your doors to anyone you do not know. Management has not given permission for any contractors to solicit in our community, and if someone claims otherwise, they are not being truthful. While we understand that soliciting is not inherently illegal in Maryland, it remains a nuisance, and we ask for your cooperation in managing this issue. If you encounter these solicitors, please ask them to leave the premises. We have already reached out to the companies involved in hopes of putting a stop to their soliciting. Your safety and comfort are our top priorities.

Upcoming Crabgrass Treatment and Fertilizer Application Scheduled

We want to inform you that Management has received notification from Heritage Landscaping regarding the scheduled application of crabgrass pre-emergent and fertilizer treatments. These applications are set to take place on Monday, May 5th, weather permitting. We sent an email blast on April 9th reminding people to opt-out if they wish.

Please note: This opt-out form must be completed each year to be added to our list.

Pool Season

As pool season approaches, we want to remind you that Crestwood will continue using the same blue access pool passes from last year, each assigned to residents only, with a unique 5-digit number. If you haven't picked up your resident pool pass yet, or you're interested in purchasing an annual guest pass, you can do so starting May 1st at the Front Desk.

Please remember that these blue passes are uniquely numbered and assigned to each resident; they are not transferable. If you lost your blue pass from last year, you will need to obtain a replacement for a fee of \$10. We provided pool passes in a pouch last year to help prevent loss, and we hope you still have that pouch along with your passes. Included in this issue of *The Village Voice* is an insert containing additional information about pool passes and their distribution.

You will see on the Pink Sheet that we are conducting two motorcoach trips, one to Mackinac Island, Frankenmuth, and the Upper Peninsula in early October, and the other to New York City at Christmas time. Programs That Benefit Seniors

On Tuesday, May 13th and Tuesday, June 10th a Service Navigator with the Frederick County Division of Aging and Independence (DAI) will be available at the Clubhouse for confidential interviews.

If you are struggling to meet monthly financial obligations, a Service Navigator can help you learn about and apply for government benefits and county services for which you may be eligible. Some examples of federal and county services, benefits, and resources that Service Navigators can help you with include:

- Maryland Access Point (MAP)
- Assistance with energy and utility bills
- Assistance with applications for homeowner's and renter's tax credits
- Assistance with applications for the Frederick County Senior Tax Credit
- Information about caregiving support resources

Service Navigators can also refer you to a Frederick County State Health Insurance Assistance Program (SHIP), where a trained counselor can provide assistance with:

- Medicare benefits, Medicare rights, and Medicare Advantage Plans
- · Billing issues with Medicare

Any resident who is interested in learning more about programs and/or services offered through Frederick County DAI (and other county agencies) can schedule a private appointment by calling the Clubhouse at 301-662-0400.

- Your assessment amount
- Your property address

- Your 5-digit unit account number: This number was assigned to you at settlement. If you do not know it, please contact the Management Office.

Once you have completed the form, click **AUTHORIZE PAYMENT**. Be sure to print or save your payment receipt for your records.
