- F. Wifi at the pool We currently have a usable signal and no further action will be taken by the BOT.
- G. Lifeguard situation Short on labor, may affect our pool season and contract with Continental Pool.
- H. Backup bus driver needed Julie is looking into this and soliciting those who have a CDL.
- I. Treatment of Crestwood II and Mountain Village condo residents at the pool Discriminatory behavior of any kind has no place in Crestwood Village. All residents of our community deserve to be treated with dignity and respect regardless of what side of Crestwood Boulevard they reside on.
- J. Offsite Meeting on Aug 16 from 10 2 pm The purpose of the meeting is to define goals and objectives.
- K. Rust on pool railing This will be corrected during end of pool season maintenance.
- L. Pool Repairs Possible leak in the pool, skimmers need to be replaced.
- M. Leaky mailbox on Box Elder concrete under the mailbox is cracked causing the box to tilt. BOT will vote on a bid to repair.
