SUMMARY OF BOT MINUTES May 25, 2021 (Unofficial)

MEMBERS PRESENT: Bill Rucker, Jeff Baggett, Doris Vierbuchen, Therese Oseneek, Tina Parrish, Doug Dawson and Paula Blundell. Also in attendance were Julie Lancaster, Property Manager, and Shirley Davis, Assistant Property Manager.

APPROVAL OF MINUTES: Doris MOVED to approve the minutes from the April 2021 meeting as amended. The motion CARRIED.

FINANCIAL REPORT: Major discussion centered around the CDs that are invested. Doris reported that she had rolled over a CD at Sandy Spring Bank into a seven-month CD at a rate of .25%. In October 2020, a CD at Frederick County Bank matured. It was

cashed out and deposited into the Capital Reserve Account, with \$300,000 now in that account. Doris MOVED to put \$100,000 from the Capital Reserve Account into a CD at a bank where she can get the best rate for a year and a half. The motion CARRIED. Doris also mentioned

the Policies and Procedures of the Finance Committee. One duty and responsibility is to review requests for proposals (RFPs) and large contractual agreements "as requested by the BOT." The BOT confirmed that this review is permitted. The Finance Committee is strictly "an advisory committee to assist (the Board) in providing financial stability to the Crestwood Village HOA."

DELINQUENCIES: A judgment has been entered for our largest delinquent account.

OLD BUSINESS: May's Security contract expires August 31, 2021. More information about services being provided and clarification on line items in the contract are still needed before the BOT can make its final decision.

The BOT will meet with a May's Security representative before making any final decisions. A decision on the proposed contract was TABLED until the next BOT meeting.

Doris MOVED to accept Petersen's Carpet and Flooring's contract to repair several mini-golf carpet areas for \$1,780. The motion CARRIED.

NEW BUSINESS: Jeff MOVED to approve the use of the community bus to full capacity once it's repaired. No masks are required if a resident is fully vaccinated; masks are recommended if someone is not fully vaccinated. The motion CARRIED.

> Jeff MOVED to have the Clubhouse return to its normal operating hours, with all activities to begin June 1st. Guests will be welcome, and the Clubhouse will start selling annual guest passes starting May 26th. Bingo will start Wednesday, June 3rd, and

they will keep financial records per the auditor's recommendation. The motion CARRIED.

Paula MOVED to move the bench in the middle of the parking lot and purchase four new benches for a total of \$1,635.49. This purchase will come from the new fiscal budget starting July 1, 2021. The motion CARRIED.

Jeff MOVED to accept the Shade Tree's Lawn and Landscaping contract for \$1,550 to remove a large tree behind 6992 Arbor Drive and to remove tree limbs from an additional three to four trees. The motion CARRIED.

Tina MOVED to accept the J-M Maintenance

proposal to replace the rotten trim around the patio doors on the first and second floors at Lantana Circle. The cost of \$1,050 will come from the condo Reserve Account. The motion CARRIED.

The BOT has received several proposals to replace windows and doors in the Clubhouse. These will need to be reviewed thoroughly with discussion of options before a final decision is made. This was TABLED until the next meeting.

MANAGEMENT: Julie wanted to confirm permission to put an insert in the June issue of *The Village Voice* about a hazardous waste drop-off event taking place on June 12th at Nymeo Field. The BOT approved the request.

INFORMATION: Jeff reminded everyone that assessments will be increasing starting in fiscal year July 1, 2021, and that coupon books will no longer be provided. Coupon books may be purchased at the Clubhouse for \$5 each. Announcements have been sent out via email and in *The Village Voice*. Doug confirmed that the underground electric fence located around a duplex property on Basswood Road was approved by the ARC Committee and is allowed in the community. thanked the Clubhouse Funds Committee for a successful yard sale and noted that Alice Tolgo and Samuel Osborn had volunteered to help the committee.
Paula informed everyone about the Neighborhood Watch volunteer list she has on record. If anyone would like to be added or taken off this list, please contact her directly. a packet about the revised HOA Document for the BOT to review. Doug is the liaison to the Election Committee. appointments of Anne Barci, Linda Bell and Bernadine Hoffman for new two-year terms on The Village Voice.

HOMEOWNER Q & A: A resident inquired about hours worked during Covid 19, since the BOT had shortened some Clubhouse evening hours. These hours were paid normally by Clagett because the office was closed, and he wanted to know if Crestwood employees still received their usual pay for the time the office was closed. Did Crestwood receive a rebate or is Crestwood due a refund? ■ A resident wanted to confirm Clubhouse evening hours.

The meeting was adjourned at 10:56.

ARC NEWS FOR JULY

ARC hopes all residents are enjoying the warmer weather. We continue to receive many applications for exterior home improvements. As of June 13th, we have received 121 applications for the current fiscal year, which will end June 30, 2021. We expect more applications in the remaining two weeks.

Important Reminder: If you plan a project that requires digging in your yard, **MISS UTILITY must be called at 811** prior to digging to avoid damaging underground utilities; i.e., cable, telephone, electric, water/sewer. This is a free service. If a contractor will be performing the dig, it is his/her responsibility to contact Miss Utility to have a ticket opened in the company name; a contractor cannot perform any work on a homeowner's ticket number. Homeowners need to open their own ticket only if performing the work themselves. Please ensure that this will be done.

ARC would like to thank homeowners for their cooperation in referring to the ARC Guidelines to determine if a project is a type that has been pre-approved (Section III Guidelines) or if it will require completion of an ARC application to obtain approval (Section IV Guidelines). We also thank those who have submitted an application when necessary. Applications can be found online on the Crestwood website (crestwoodvlg.net) or in the Clubhouse office.

- ✓ We collect nonperishable food for the local Food Bank. There is a basket under the easel by the coat room door.
- ✓ Left-over yarn from your finished projects can be used by the Prayer Shawl group for their many projects. They donate items to the hospital and to those who have a need for the comfort these items bring to them. Leave at the front desk.
- ✓ We collect used eyeglasses and hearing aids for the Lions Club. The eyeglasses are used in other countries, and the hearing aids go to the University of Maryland to help with a program for the deaf and the needy in Maryland. The basket is on the wall near the coat closet.


ASSESSMENT INCREASE REMINDER




