IN OUR BACKYARD

The Hagerstown Aviation Museum boasts vintage aircraft on display in a former 1943 Fairchild Aircraft Flight Test Dome Hangar. The *Wings and Wheels Expo* on Saturday, September 13th, highlights historic aircraft and various aircraft exhibits. This is the world's largest collection of 25 historic Fairchild aircraft! For history buffs, the Fairchild assembly line in Hagerstown produced an estimated 5,000 aircraft between 1939 and 1944 for military use during WWII. The *Expo* also features a Cruise-In showcasing antique and classic cars, trucks, antique tractors, motorcycles and more. There will also be live music and food.

This day trip is sponsored by the Crestwood Veterans and is open to all Crestwood residents. Refer to the Pink Sheet for details.



For Crestwood Village, year-to-date (YTD) income exceeded YTD expenses. For CV1, YTD expenses exceeded income. For CV2, YTD income exceeded expenses.

Memorial donations were made to the charities chosen by Myrtle Rundell and James Graham in memory of their deceased sons.



MANAGER'S CORNER

Shredding Bin

Management has observed that many residents are placing recyclable materials such as newspapers, magazines, filing folders and envelopes into the shredding bin. This causes the shredding bin to fill up quickly. (See photo of the recyclable items we had to remove from the shredding bin.)

Please remember that the shredding bin is scheduled to be emptied every other month and is intended exclusively for documents containing sensitive information. Some examples of sensitive information are taxpayer paperwork, bills, medical records, and any documents containing banking information or social security numbers. If a document contains only your name and address, please place it in the recycling bin.



Condo Parking (Basswood Rd / Box Elder Ct)

Management would like to remind everyone about the guidelines regarding guest parking at the condos on Basswood Road and Box Elder Court. Guest parking spaces are reserved exclusively for visitors and are not meant for use by additional family members living in the unit. The guest parking passes provided are intended solely for guests when they visit, not for friends or family members who reside with you.

Any vehicle parked in a guest spot for more than three consecutive days, or any attempt to switch vehicles between reserved spots and guest spots, will result in your vehicle being towed (at least four (4) vehicles have been observed doing this).

Management will have vehicles towed if guest spot parking is abused. Warning notices have not been effective in controlling the situation. Thank you for your cooperation.

Inspections and Violation Notices

Management will be conducting Fall inspections starting this month, weather permitting. We will be checking for tree stumps, excessive weeds around the property, and shrubs and trees that require attention.

If a violation is identified, residents may receive up to three (3) warning letters. Each letter will allow ten (10) days to address the violation. If the violation persists ten (10) days after the third written warning, a fine of \$5 per day will be charged until the violation is resolved.

Lobby Electrical Work

Brandenburg Electric will be installing wafer lights in the ceiling of the Clubhouse lobby on <u>Tuesday</u>, <u>September 23rd. The Clubhouse will be closed for the day.</u> However, the Community Meeting will still be held in the auditorium. Residents can attend the meeting by using the double doors in the auditorium. (Restrooms will be available. Please be cautious when going through the Clubhouse lobby.)

Management will be available in the Clubhouse during normal business hours to handle calls and conduct business. It may be noisy and messy during the installation, so there will not be a Front Desk receptionist helping with calls. Management will be receiving all phone calls. If the lines are busy, please try again in a few minutes. Thank you for your understanding.

OPEN FORUM ON SECURITY

Over 90 Crestwood residents gathered on August 11th to discuss ideas to improve security in our community. Residents Cassandra Bailey and Mike Kiefer provided a presentation which included a variety of physical security enhancement devices and their costs. Discussion items included: establishing an ad-hoc group to follow up, examining the existing security contract, discussing enforcement of the contract, improving identification of both the patrol. vehicle and the guard, and installing larger signs and cameras at the entrances.

Residents were encouraged to keep their entrance lights on and have the number for the security company in their phone contacts. We can all help our neighbors by being alert and communicating concerns.

Wildlife

This is a reminder that feeding wildlife, including squirrels, is against the HOA's CCRs.

DECLARATION OF COVENANTS, CONDITIONS AND RESTRICTIONS (CCRs)
ARTICLE III: Property Rights
Section 4. Restrictions Applicable to the Property.

O. No animals of any kind shall be bred in any Home or Lot or upon the Common Property except as permitted by the Rules and Regulations of the HOA regarding the keeping of domestic pets. Additionally, no wild animals shall be fed with the exception of birds from authorized bird feeders as described in the ARC Guidelines.

Feeding wildlife can lead to other issues, including human food can harm animals, and natural diets and natural foraging habits can be disrupted.

Please help us maintain a safe and healthy environment for both residents and wildlife. If you see any wildlife in the area, enjoy observing them from a distance, but remember not to provide food sources.

The next meeting is September 2nd at 11 AM in the Clubhouse.




