II. Treasurer's Report

- Reported favorable cost savings related to the recent painting project.
- Year-end report from Claggett Management is still pending for December.
- November financials reflected expenses exceeding projections for Crestwood Village and CV1 and CV2. Doris reported balances in the Snow Contingency and Reserves accounts for all three associations

III. Information / Potential Board Agenda Items

1. Thanksgiving Dinner Refunds
 - To affirm the electronic vote (12/16) to issue full refunds to residents who did not receive a complete turkey meal.
 - Refunds have been issued to all but two residents; remaining checks are available at the front desk.
2. Tree Removal
 - To affirm the electronic vote (1/5) approving removal of a leaning tree on Oleander Place due to safety concerns.
 - Work will be funded through operating expenses.
3. Shelf Painting Addendum
 - To affirm the electronic vote (1/7) approving an addendum to paint hallway shelves white, as originally intended but omitted from the initial scope.
 - Funding will come from operating.
4. IT Support Proposal
 - Will discuss consideration of ongoing computer maintenance and support services.
 - Interim assistance has already been provided on a voluntary basis.
5. Mountain Village Dumpster Enclosure
 - Will discuss options to enclose the dumpster area to reduce illegal dumping and additional trash pickups.
6. Exterior Maintenance Service Chart
 - Briefly went over the current service chart, including snow removal, lawn care, minor repairs, and possibly driveway caulking.
 - Updates will be made as needed at the Board meeting next week.
7. Fence on Crestwood Boulevard
 - Provided updates on the fence project.
 - Progress is dependent upon completion of Verizon's work and addressing impacts on nearby private homes, including final placement. More discussion to take place at the Board meeting.
