REGULAR MONTHLY MEETING OF GLASSPORT BOROUGH COUNCIL, JULY 18, 2023

The regular monthly meeting of Glassport Borough Council was called to order by Anthony Colecchi, President of Council.

Pledge of Allegiance

Prior to the meeting we had an Executive session to discuss personnel and receive information.

Public comments – Agenda Items only.

Toni Cregan - It is not a secret that I have been Emailing the office in regard to my opposition in selling the Sewage Treatment Plant. I have worked for several sewer authorities and I have attended many meetings about privatizing sewage plants and what it does to the community. I know we are one of the lowest rate payers in the region. I am wandering why there is only a usage increase and not a per unit flat fee attached to the bill.

Colecchi – We discussed that at our workshop last week, and we were advised to increase the volumetric fee and not the flat fee.

Skiba – We have been working with this company and our engineers, and they came up with an analysis of why we need to increase our rates and to what point they need to be increased. The first phases of reaching our Long Term Control Plan requirements is going to be approximately \$1.6 million to complete and this increase will cover that. At this rate, to meet all of our issues in our Capital Improvement Plan, our rates are going to be more than if we were to sell it to someone else.

Borough Manager's Report - Elaina Skiba

The Borough was awarded a CDBG grant for \$34,092 toward the walking track at the Ninth Street Park. After reviewing what the previous engineer submitted for this grant and discussing it with our new engineer, the cost is possibly \$62,000 and not the original \$128,000 that was submitted. I will contact the COG and see if the grant application can be revised. If that is acceptable, we will be able to fund the rest of the project from the Trust.

Due to information received last week, the Town Hall to discuss the future of the sewage plant that was scheduled for Tuesday, August 22 has been postponed. There are discussions that need to be had between the interested parties and the EPA. Once we receive the outcome of these talks, we will update the residents and reschedule the Town Hall.

Motion made by Kowalski second by Norelli to enter into an agreement with LC Deer Disposal, LLC for the removal and disposal of road killed deer in the Borough, pending receipt of additional insurance information, releasing the Borough of liability.
