Borough Manager's Report - Elaina Skiba

Whole Home Repair update:

8% of the projects applied for have been funded, with 30 projects being completed.

The program has made it through the State House and waiting to pass the Senate to keep this funding going.

We are looking for answers from Action Housing as to where the funding was distributed.

They are opening the program again starting Oct 16. I am waiting on instructions from Action Housing before I can put the information out to our residents. I do know updated income information will be requested for applications already submitted.

Tim Joyce is going to get all of the information on this matter.

Fifteen letters were mailed notifying resident with delinquent sewage that their properties would be liened by the Borough if the balances were not paid. Of the letters sent, two accounts totaling \$4,375.65 have paid or have made payment arrangements. On Friday, letters were sent certified mail to those who haven't responded. Anyone not responding in two weeks will be turned over to the Solicitor to have the lien filed on the property. The total of the delinquent accounts is \$35,787.42.
