Wedding Music Agreement

Performance description: Our repertoire includes works from Classical era, Jazz, Pops, Covers. We accept requests and will make sure to purchase new music if needed for your event. Fee will apply if more than 2 new songs are requested which are not in our repertoire. Will set up at least 30 minutes prior to prelude music. Attire: Elegant black. Chairs for the performers must be provided, armless if possible.

1. For background music over 1 hour a 5-10 minutes break is required for the performer.
2. Parking fees are to be paid by the purchaser.
3. For outdoor engagements, a shaded floor must be prearranged for the artist. Instruments cannot be exposed to direct sunlight. If there is no shade (i.e. umbrella, canopy, etc) this is considered a breach of contract and the artist will not be able to play at the event.
4. If rainy weather conditions prevail, purchaser must arrange for an alternative site.
5. If the bridal party is late on the event day there will be an additional \$25 per musician overtime fee every 30 minutes.
6. If this agreement is cancelled by the purchaser less than 30 days before the event, the balance shall be required in half. Deposits are nonrefundable.

Cash is accepted on the event day if only is received before musicians start playing the Prelude. If the purchaser fails to pay musicians timely on the wedding /event day there will be an overtime fee of \$25 per musicians.
