

At Arce Aircraft Management your privacy is paramount to us. At Arce Aircraft Management we have a few fundamental principles:

- We don't ask for your personal information unless we truly need it.
- We don't share your personal information with anyone except to comply with the law, develop our products, or protect our rights.
- We don't store personal information on our servers unless required for the on-going operation of one of our services.
- Below is the Ui Store (Arce Aircraft Management) privacy policy which incorporates these goals. If you have questions about deleting or correcting your personal data please contact our support team.

Arce Aircraft Management. ("AAM") operates several websites. It is AAM's policy to respect your privacy regarding any information we may collect while operating our websites.

### **Website Visitors**

Like most website operators, Arce Aircraft Management collects non-personally-identifying information of the sort that web browsers and servers typically make available, such as the browser type, language preference, referring site, and the date and time of each visitor request. The reason for collecting non-personally identifying information is to better understand how the Arce Aircraft Management visitors use its website.

The Arce Aircraft Management also collects potentially personally-identifying information like Internet Protocol (IP) addresses. The Arce Aircraft Management does not use such information to identify its visitors, however, and does not disclose such information, other than under the same circumstances that it uses and discloses personally-identifying information, as described below.

### **Gathering of Personally-Identifying Information**

Certain visitors to the Arce Aircraft Management websites choose to interact with the Arce Aircraft Management in ways that require the Arce Aircraft Management to gather personally-identifying information. The amount and type of information that the Arce Aircraft Management gathers depends on the nature of the interaction. For example, we ask account holders at PayRecord.com to provide a username and email address. Arce Aircraft Management collects such information to fulfill the purpose of the account holders interaction with the web site. Arce Aircraft Management does not disclose personally-identifying information other than as described below. And account holders can always refuse to supply personally-identifying information, with the caveat that it may prevent them from engaging in certain website-related activities.

### **Aggregated Statistics**

The Arce Aircraft Management may collect statistics about the behavior of visitors to its websites. Arce Aircraft Management may display this information publicly or provide it to others. However, Arce Aircraft Management does not disclose personally-identifying information other than as described below.

### **Protection of Certain Personally-Identifying Information**

Arce Aircraft Management discloses potentially personally-identifying and personally-identifying information only to those of its employees, contractors and affiliated organizations that (i) need to know that information in order to process it on Arce Aircraft Management' behalf or to provide services available at Arce Aircraft Management websites, and (ii) that have agreed not to disclose it to others. Some of those employees, contractors and affiliated organizations may be located outside of your home country; by using Arce Aircraft Management websites, you consent to the transfer of such information to them. Arce Aircraft Management will not rent or sell potentially personally-identifying and personally-identifying information to anyone. Other than to its employees, contractors and affiliated organizations, as described above, Arce Aircraft Management discloses potentially personally-identifying and personally-identifying information only when required to do so by law, or when Arce Aircraft Management believes in good faith that disclosure is reasonably necessary to protect the property or rights of the Arce Aircraft Management, third parties or the public at large. If you are a registered user of the Arce Aircraft Management website and have supplied your email address, the Arce Aircraft Management may occasionally send you an email to tell you about new features, solicit your feedback, or just keep you up to date with the Arce Aircraft Management and our products. Arce Aircraft Management takes all measures reasonably necessary to protect against the unauthorized access, use, alteration or destruction of potentially personally-identifying and personally-identifying information.

### **Cookies and Monitoring**

Arce Aircraft Management places cookies, which are small data files, on your computer or handheld device. This is standard practice for all websites. Cookies are essential for helping us deliver a better quality website and online shopping experience for our customers.

#### **What are cookies?**

Cookies are small data files which are placed on your computer or other mobile or handheld device (such as smart 'phones or 'tablets') as you browse this website. They are used to 'remember' when your computer or device accesses this website. The cookies are essential to the effective operation of our website.

#### **Information collected**

Our cookies only collect relevant information to provide users with a more efficient browsing experience. We also use Google analytics cookies to monitor our web traffic

and other third party cookies like BSA (BuySellAds) to manage our advertising. We do not collect personal information other than the details you provide if you create a members account with us. We may monitor traffic to our site and collect the following information:

- The IP address of your computer.
- The referring website from which you have got to our website from.

The reasons for this are:

- To make ongoing improvements to our website based on this data.
- To see our most popular sources of business.

By using and browsing the website, you consent to cookies being used in accordance with our policy. If you do not consent, you must disable cookies or refrain from using the site.

### **What happens if I disable cookies?**

This depends on which cookies you disable, but in general the site may not operate properly if cookies are switched off. If you only disable third party cookies you will not be prevented from using the website or making purchases in our store.

### **Business Transfers**

If Arce Aircraft Management, or substantially all of its assets, were acquired, or in the unlikely event that Arce Aircraft Management goes out of business or enters bankruptcy, user information would be one of the assets that is transferred or acquired by a third party. You acknowledge that such transfers may occur, and that any acquirer of the Arce Aircraft Management may continue to use your personal information as set forth in this policy.

### **Privacy Policy Changes**

Although most changes are likely to be minor, Arce Aircraft Management may change its Privacy Policy from time to time, and at Arce Aircraft Management' sole discretion.
