HORSE RIDING AGREEMENT AND LIABILITY RELEASE FORM

This form must be completed by and for each participant.

PLEASE READ CAREFULLY BEFORE SIGNING: SERIOUS INJURY MAY RESULT FROM YOUR PARTICIPATION IN THIS ACTIVITY. FIRST BLUE LLC DOES NOT GUARANTEE YOUR SAFETY OR THAT OF YOUR HORSE. IT IS HEREBY AGREED TO AS FOLLOWS THAT:

A. REGISTRATION OF RIDERS AND AGREEMENT PURPOSE- I, the following individual hereinafter known as the "RIDER", and the parents or legal guardians thereof if a minor, do hereby voluntarily request and agree to participate in horse riding on premises (FIRST BLUE LLC), and that this RIDER will ride his/her own horse or one borrowed or leased by RIDER'S own arrangement today and on all future dates:

B. AGREEMENT SCOPE AND TERRITORY AND DEFINITIONS – This agreement shall be legally binding upon me the Registered RIDER, and the parents or legal guardians thereof if a minor, my heirs, estate, assigns, including all minor children, and personal representatives; and it shall be interpreted according to the laws of Suffolk County, NY. Any disputes by the RIDER shall be litigated in and venue shall be Suffolk County, NY.

The term "HORSE" herein shall refer to all equine species. The term "HORSEBACK RIDING" or "RIDING" herein shall refer to riding or otherwise handling of horses, ponies, mules, or donkeys, whether from the ground or mounted. The term "RIDER" shall herein refer to a person who rides a horse mounted or otherwise handles or comes near a horse from the ground. The terms "I", "me", "my" shall herein refer to the above registered rider and the parents or legal guardians thereof if a minor.

C. ACTIVITY RISK CLASSIFICATION – Horseback riding is classified as RUGGED ADVENTURE RECREATIONAL SPORT ACTIVITY, and that there are numerous obvious and non-obvious inherent risks always present in such activity despite all safety precautions. According to NEISS (National Electronic Injury Surveillance Systems of United States Consumer Products) horse activities rank 64th among the activities of people relative to injuries that result in a stay at U.S. hospitals. Related injuries can be severe, requiring more hospital days and resulting in more lasting residual effects than injuries in other activities.

D. NATURE OF RIDING HORSES – No horse is a completely safe horse. Horses are 5 to 15 times larger, 20 to 40 times more powerful, and 3 to 4 times faster than a human. If a rider falls from a horse to ground it will generally be at a distance of from 31/2 to 51/2 feet, and the impact may result in injury to the rider. Horseback riding is the only sport where on much smaller, weaker predator animal (human) tries to impose its will on, and become on unit of movement with, another much larger, stronger prey animal with a mind of its own (horse) and each has a limited understanding of the other. If a horse is frightened or provoked it may divert from its training and act according to its natural survival instincts which may include, but are not limited to: stopping short, changing directions or speed at will; shifting its weight; bucking; rearing; kicking; biting; or running from danger.

E. RIDER RESPONSIBILITY – Upon mounting a horse and taking up the reins, the RIDER is in primary control of the horse. The RIDER'S safety largely depends upon his/her ability to carry out simple instructions, and his/her ability to remain balanced aboard the moving animal. The RIDER shall be responsible for his/her own safety.

F. CONDITIONS OF NATURE – First Blue LLC is NOT responsible for total or partial acts, occurrences, or elements of nature that can scare a horse, cause it to fall, or react in some other unsafe way. SOME EXAMPLES ARE: thunder, lightning, rain, wind, wild and domestic animals, insects, reptiles, which may walk, run, fly near, bite and/or sting a horse or person; and irregular footing on out-of-door groomed or wild land which is subject to constant change in condition according to weather, temperature, and natural and man-made changes in landscape.

G. INSPECTION OF PREMISES – RIDER has inspected First Blue LLC facilities and trails and is satisfied that all premises conditions are reasonably safe for RIDER'S intended purpose, usage and presence upon the First Blue LLC premises.

H. ACCIDENT/MEDICAL AND PERSONAL LIABILITY INSURANCE – Should medical treatment be required, I and/or My own accident/medical insurance company shall pay for all such incurred expenses. Should my actions or that of my horse cause injury or damage of any kind, I and/or my own personal liability shall pay for such damages.

I. PROTECTIVE HEADGEAR WARNING – I have been fully warned and advised by First Blue LLC that the RIDER should purchase and wear protective headgear (riding helmet), and that the wearing of such headgear while mounting, riding, dismounting, and otherwise being around horses, may prevent or reduce severity of some head injuries and even prevent death from happening as the result of a fall or other occurrence. All RIDERS are required to wear protective headgear.

J. LIABILITY RELEASE – In consideration of First Blue LLC (First Blue LLC – employees & associates) allowing my participation in this activity, under the terms set forth herein, I, the RIDER, and the parent or guardian thereof if a minor, do agree to hold harmless and release First (First Blue LLC – employees & associates,), its owners, agents, employees, officers, members, premises owners, insurers, and affiliated organizations from legal liability due to First Blue LLC (First Blue LLC – employees & associates) ordinary negligence; and I do further agree *that except in the event of* First Blue LLC (First Blue LLC – employees & associates,) *gross negligence and willful and wanton misconduct*, I shall not bring any claims, demand, legal actions and causes of action, against First Blue LLC (First Blue LLC – employees & associates) and/or its associates, for any economic and non-economic losses due to bodily injury, death, property damage, sustained by me and/or my minor child or legal ward in relation to the premises and operations of First Blue LLC (First Blue LLC – employees & associates), to include while riding, handling, or otherwise being near horses owned by or in the care, custody and control of First Blue LLC (First Blue LLC – employees & associates).

- Child must wear certified horseback riding helmet during the riding portion of camp. We highly recommend to purchase a helmet before the start of camp along with riding (paddock) boots. Helmets and boots can be purchased locally at The Tack Trunk or ordered online (Smartpak equine, Dover Saddlery are reputable sites). If you have any questions on brand or what to order please contact us via email. Helmets and paddock boots are available to borrow if needed.
- Proper attire for camp is a T-shirt and riding pants or any long pant.
- Proper footwear is also required no open toe shoes, sandals, or flipflops. We recommend purchasing paddock boots prior to the start of camp.
- Send child with nut free lunch, snacks, and drink (please send a water bottle that is able to be refilled. We are able to refill during camp if needed.
- Lunch can be refrigerated but not heated. Please inform camp counselor at drop off if lunch needs to be refrigerated.
- Written notice must be given for child to get picked up by someone other than parent/guardian
- Any sort of medicine or medication is prohibited at camp
- If child has an allergy and must have epi-pen or other rescue medication prior written approval and doctor note must be provided
- Please apply sunscreen and bug spray prior to drop off. Counselors are not permitted to apply.
- Our camp day includes 45 minutes of riding time in a group lesson
- During camp children will learn basic horsemanship skills including: grooming, tacking, bathing.
- There will be an assortment of horse related crafts and games during each week
- Every Friday there will be a camp horseshow that parents can attend. Please ask camp counselor at drop off what time your child will be riding.
- Private riding lessons are also available after camp and on weekends please inquire for information.
- In the event of inclement weather camp will run. Riding will take place in our indoor arena and activities will be moved indoors
- Please be prompt to pick up your child at the end of camp.
