## Police Matters

"Overnight Thefts" - the main area of concern - remain. Residential properties are often targeted for petrol type power tools, and farm buildings are always a favourite. Please ensure that "expensive" items are locked or chained when not in use. Colleagues in Shrewsbury have seen an increase in thefts from vehicles and garages on the housing estates within the town overnight and this includes expensive bicycles - which is another item that requires "bolting down" - even when in a garage.

Now evenings have drawn in, check that your security lights are still working and make sure you "lock up" earlier in the evening to prevent unwanted visitors from helping themselves, aided by the cover of more darkness. If you would like me to visit and take a walk around your property, please give me a call on 07814 042410.

Following complaints from locals - there will be some Speed Enforcement Checks being conducted in both Westbury and Yockleton over the next few months.

Stay safe and please get in touch with any questions or concerns.

Please continue to lock up outbuildings and report any sightings via 101 and also via some of the excellent community Facebook pages to alert your neighbours that they are about.

I am still working as usual and if you would like me to have a walk around your property to give security advice, please get in touch. I can manage to shout over two metres but I am missing my usual cups of tea, which would be a pre-requisite for a visit!

As always, keep garages, sheds and outbuildings locked and - if possible - alarmed. Simple battery powered alarms have improved and noise is always a good deterrent if a thief has managed to get into your "Lock Up". Quad bikes and push bikes continue to be popular amongst thieves, so both need chaining up/bolting down.

Security marking can help recover stolen items and there are a number of options available. Please remain vigilant and ensure everything gets locked all the time - not just last thing at night. Keep in touch with your neighbours by telephone and - for those who use social media - post strange vehicles and unusual events. Neighbourhood Watch is nothing complicated or formal. It's just keeping an eye out, but also letting others know - including me - if you have the registration numbers of vehicles that don't look or feel right. It doesn't matter if it is via Facebook, WhatsApp or a text message. Email me and Joe Bradley via :

If you have outside lights and security lights, make sure they are working. Any garden ornaments of value or interest need to be well secured, as do power tools and garden equipment, as they remain a desirable item for opportunist night-time thieves.

Please be aware of any unusual callers to your house or area, even those who may make themselves look legitimate by offering gardening services or asking for directions. Always try and make a note of vehicle registration numbers or anything distinctive about the vehicle and callers.

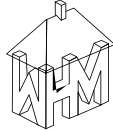

## **Westbury W I**

On Wednesday 6 January 2021, seven members of Westbury WI : Connie, Jill, Beryl, Sally, Chris, Helen and Penelope - plus two visitors - enjoyed a talk by the Speaker Penny Ward via Zoom about the Flax Mill at Ditherington (a suburb of Shrewsbury) which was built in 1797. This is the first iron-framed building in the world and is described as "the Grandfather of Skyscrapers".

The building - known locally as The Maltings - is in the hands of Historic England and the site is under restoration. The Visitor Centre and Stable Blocks are open to the public under Covid-19 instructions. Penny Ward was thanked by our President Jill Jones.

## **Census 2021**

### **2021 Census in Shropshire**

The Office of National Statistics (ONS) will carry out the 2021 Census on 21<sup>st</sup> March 2021.

The Census will provide a picture of England and Wales, revealing the size and characteristics of the population and providing valuable information that will be used to inform Policy Development, Funding Allocations and future Service Planning. The 2021 Census will be predominantly an online Census Questionnaire but with a Questionnaire in paper format made available to people who are unable to take part online.

Each household in Shropshire will receive a postcard during the period 22<sup>nd</sup> to 27<sup>th</sup> February 2021 raising awareness of the 2021 Census, followed by an initial Contact Pack (between the 3<sup>rd</sup> and 12<sup>th</sup> March 2021) requesting each household to complete the Census Questionnaire online or by requesting the Questionnaire in paper format.

Help will be available to Shropshire households via Support Centres located in the Libraries in Shropshire's largest six market towns (Shrewsbury, Oswestry, Bridgnorth, Market Drayton, Ludlow and Whitchurch), or via online guidance, a National Helpline and via trained Field Staff. The Questionnaire can also be completed using a mobile phone.

ONS 2021 Census plans will be responsive to the latest Guidelines from Central Government on Social Distancing during the Covid-19 pandemic and so may be subject to change.

## February 2021 : A Fresh Approach to Lent

As I write this short article we are fast approaching the season of Lent, the six week preparation for Easter which begins on 21st February. Lent means different things to different people, mostly people tend to think of the forty days that Jesus spent in the wilderness, where he was tempted to misuse his heavenly powers for personal gain and comfort. Even non-religious people have adopted the tradition of giving something up for Lent and, whilst this is not for spiritual reasons, it still offers health benefits, trying to remain strong, overcoming the power of the will of desire and want, whether that be for material goods or consumable delicacies.

Someone once told me that they weren't going to give anything up for Lent this time, but they were just going to try and be 'a nicer person' for Lent. In a sense you are giving something up, I replied. Because you are giving up the earthly / human reaction to speak before you think, or to respond with unkindness when you have been a victim of injustice or neglect. Jesus said:

*"You have heard that it was said, 'Love your neighbour and hate your enemy.' But I tell you, love your enemies and pray for those who persecute you, that you may be children of your Father in heaven. He causes his sun to rise on the evil and the good, and sends rain on the righteous and the unrighteous. If you love those who love you, what reward will you get ? Are not even the tax collectors doing that ? And if you greet only your own people, what are you doing more than others ? Do not even pagans do that ? Be perfect, therefore, as your heavenly Father is perfect."*

The original purpose of the season of Lent was to be a time of preparation. To help us to be more immersed into the meaning of Easter. Early Christians would go through a period of cleansing through self-denial, not for health benefits, but to spend time in the quietness and stillness, listening for the voice of God. When they felt hungry, they would pray, so that their spirits might be fed with spiritual food which nourishes both body and soul. Maybe today we could give up scrolling through Facebook or emails, look up from our smart phones and smile at whoever is sitting opposite ? Maybe we could give up a packet of biscuits and put them in the food hub in the Church porch for those who might otherwise go without. There are many ways to approach Lent, but in the main it is about 'stopping' getting off the humdrum of life and having a spring clean of our bodies and minds.

However you spend it, may God bless you and keep you.

**The Fifteen Stations of the Cross** : commencing Monday 1<sup>st</sup> February at 7:30pm and running twice each week until Easter, we are having half hour meditations and reflections on Zoom. These will focus on the traditional fifteen Stations of the Cross which are recorded in the gospels; beginning at the Garden of Gethsemane and ending at the resurrection of Christ.

The Stations of the Cross present us with an opportunity to encounter Christ, get a deeper

understanding of his suffering and for us to deny ourselves (even just for half an hour) and journey with him. But more than that, as we meditate and reflect, we encounter ourselves too, perhaps we find ourselves with Peter in denying Jesus three times or perhaps we find ourselves with Mary, weeping at the sight of her son's pain. As we place ourselves in the crucifixion narrative, we do it in the light of Christ's victory, forgiveness and grace. Such is the power of the cross even two thousand years on.

## SmartWater Kits

**Reminder** : As per the item below which was posted on Westbury Parish Council's website on 11 November 2020, four hundred SmartWater Kits were sent out but, if you have not received your SmartWater Kit, please contact Sarah Smith, Clerk and RFO, Westbury Parish Council by email <clerkwypc@aol.co.uk>.

### 11 November 2020

Households in Westbury Parish will soon be receiving a free SmartWater kit purchased uniquely for their household by your local Parish Council working alongside the "We Don't Buy Crime" team and West Mercia Police to **protect your home from burglary**.

Due to the current restriction of Covid-19 and the need to self-isolate, this kit has been safely pre-registered to your address and **this solution is now unique to your home**. This procedure is in line with Royal Mail General Data Protection Regulations/Guidelines; however should you wish to opt out of this initiative, simply email :

and we will remove the kit/your record from the initiative.

### Why protect your items with SmartWater ?

If your items were stolen, the Police could trace them back to you. By SmartWater protecting your items you deter a burglary.

The We Don't Buy Crime team works vigorously to encourage all organisations who buy items off the public: retailers, scrap metal merchants, auction houses, antique and jewellery dealers to check for SmartWater, therefore sabotaging the re-sale avenue of stolen goods. We have over 200 businesses that are actively doing this.

Whenever a suspect is arrested and brought into custody in West Mercia, they are checked for SmartWater. If a suspect is arrested for burglary, their premises are checked for other stolen goods/SmartWater.

**In a court of law, SmartWater is sufficient evidence to convict a criminal with a 100% conviction rate in court to date. Since 1995 over 1000 SmartWater convictions have taken place and a far greater number of burglaries prevented in our neighbourhoods.**

SmartWater protected areas see an **average reduction in burglaries of 65%** due to all of the above facts; that is why it is essential that the window stickers go up on your property in full view - this is a huge burglary deterrent.

### What's in SmartWater ?

SmartWater is made up of 85% Water and 10% polymers plus a unique mix of rare earth metal traces which makes every bottle unique.

SmartWater is invisible in daylight but fluoresces under UV light and cannot be removed once fully adhered to its surface.

**Merger of Worthen and Pontesbury Medical Practices  
3 December 2020**

**Frequently Asked Questions**

- Will you remain an NHS practice, offering a broad range of “private” treatment; or is this the beginning of a “private medical care” practice ?

Response : Yes, we will absolutely be remaining as an NHS practice, there is no intention of becoming a private medical practice.

- Will a satisfactory level of autonomy be maintained, both for the administration and for the medical aspects of a GP practice when you combine the clinical and administrative teams ?

Response : The structure is being looked at so everyone has appropriate line management but - as in any practice - a degree of autonomy is required to carry out day-to-day duties.

- Will there be resultant job losses when the amalgamation is finalised ?

Response : There are no redundancies planned.

- Will best practice be implemented across both sites ?

Response : We will be looking at all our processes at both sites with the plan to take the best from each practice going forwards. We have already started to identify areas where each practice has strengths and how we implement them across both sites. By merging, the expectation is that services will be strengthened for patients. Patients will still be able to access the health care they need at either site and should have a greater degree of flexibility of when or where they are seen and a greater choice of clinicians.

- Will telephone triage be undertaken and applied when booking appointments ?

Response : With the Covid-19 pandemic we have had to adapt to a very different way of working in order to keep patients safe and this has meant a big change to how we run our appointments system. This has been accepted by patients and we have found that telephone triage is working well.

- Will we be able to see a doctor of our choice e.g. the one we are used to seeing ?

Response : As the practices are merging, all doctors will be working for the new “Pontesbury and Worthen Medical Practice”, but you are perfectly entitled to be seen by whichever doctor you choose, subject to availability and your clinical need at the time, and you will have greater choice of appointment and location being able to be seen at either site.

- For those with transport issues, will it be possible to see a Pontesbury GP at the Worthen Medical Centre ? What sort of service is envisioned for the Worthen practice ?

Response : Both sites will run as part of the merged practice and GPs will run surgeries at both sites. Although obviously Worthen can only house one GP surgery at a time, patients will be able to attend either site. There will however be occasions when demand is high, and choice at either site may be limited. As such we would, on occasion, be likely to have urgent assessments being done on one site.

Home visiting is only available for patients who are bed-bound, or house-bound for medical reasons. Generally patients who can attend hospital outpatients would also be expected to have arrangements in place to allow them to attend the surgery.

# **Lockdown Restrictions - Statement from Chief Constable Anthony Bangham**

Chief Constable of West Mercia Police, Anthony Bangham, has issued a statement following the announcement of the new lockdown for the country as we continue to work together to prevent the further spread of Covid-19.

Chief Constable Bangham said: "Over the last year the vast majority of people in our communities have kept to the rules and I am confident that they will continue to do so through this new phase of the pandemic."

"West Mercia Police will continue to be visible across our villages, towns and cities working with our partners to do all we can to prevent the spread of the virus. As the public would expect, we will respond firmly, but fairly, using all the powers available to us to take action against those people that flout the laws and knowingly put others at risk."

"Policing across West Mercia will continue unabated throughout the lockdown and, as the Prime Minister outlined yesterday, help is available to anyone whose home is not a safe place to be. We would like to emphasise that we are still here for you 24/7."

"We are awaiting the official regulations from the Government and will share them on our website and social media channels as soon as we can."

# 11 arrested during Christmas crackdown on

## drugs in Shropshire

11 people were arrested on Wednesday (23 December) during a targeted day of activity to crackdown on county lines across Shropshire.

Yesterday (Wednesday 23 December) West Mercia Police supported Merseyside Police with its proactive officer investigation work and subsequent premises searches.

11 people were arrested for various offences including possession with intent to supply class A, possession with intent to supply Class B, possession of a bladed weapon, as well as drink and drug driving offences.

More than £5,500 was also seized on the day and officers also conducted eight stop and searches during the day.

## Police offer free kits to help protect cars from Catalytic converter thieves

Police are offering 30 property marking kits following an increase in catalytic converter thefts.

Since September there has been an increase in reported incidents within South Worcestershire; however this type of theft has been on the rise throughout the country. Catalytic converters have expensive metallic components, including platinum, which make them attractive to thieves who in turn make profit from onward sale and disposal.

It can take a thief less than two minutes to remove a catalytic converter from its housing in the car exhaust pipe, but there are a number of ways the public can help protect their property by fitting aftermarket devices.

To help reduce the chance of your vehicle being targeted by thieves, the following are preventative measures that can be taken :

Keep your vehicle in a locked garage when it is unattended .

If you park your car on a driveway, consider installing motion activated lighting/CCTV.

Otherwise, park in a well-lit, populated area as close to your property as possible.

Forensic security marking kits are available to mark your catalytic converter.

Devices are also available that can be fitted to your converter to deter removal.

Consider installing a THATCHAM approved alarm to your vehicle, ones that activate if the car is lifted or tilted are particularly effective.

Sergeant Simon Hallam from South Worcestershire's Problem Solving Hub said: "This is an increasing problem nationally due to the value of these converters increasing. This is why we are offering property marking kits on a first come first serve basis for residents in South Worcestershire in order to protect their vehicles."

"I would urge vehicle owners to take advantage of the offer of these property marking kits and for them to visit Secure By Design's website for more information on keeping your valuables safe."

"As a force we are taking further measures to prevent these crimes from happening and have increased our overnight patrols in all areas across South Worcestershire. If any suspicious activity is observed please ensure that Police are contacted in order that a quick and appropriate response can occur"
