Rules & Regulations

**Space:** Each Gumbo teams' space is 10x10. Teams are encouraged to decorate their area. Teams must furnish ALL cooking equipment including tents, tables, chairs, propane cookers, water, etc. There is NO ELECTRICITY on 11<sup>th</sup> street. Your location on 11th street will be based on the date the application/payment is received. You will receive an email with slot placement the week before the cookoff.

**Gumbo:** Gumbo & Roux must be cooked on site the day of the cook-off. Roux cannot be prepared in advance. Your Gumbo may include meat, poultry, shellfish, alligator, venison, spices and your secret ingredients. Make sure you have enough to serve 700 + samples and a minimum of 1 quart for judging ~ no rice.

**Check-In:** Check in and set up begins at 6:00am. Please check in at the Bandera ProRodeo Association tent to let us know you have arrived. Your cooking area will need to be ready, and all vehicles removed as soon as possible, but no later than 9:00am NO EXCEPTIONS.

**Team Meeting:** 8am Review of Rules and Receive Supplies.

**Tastings:** Teams are required to give out tastings in a 4oz cup. Tasting supplies will be provided for you by the Bandera ProRodeo Association. Bring any necessary containers you would need for these supplies. Tastings for the public will begin at 11:00am. Patrons will present your booth with one ticket per tasting. Please keep all peoples choice tickets in the container provided to you as this will be part of the judging.

**Judging:** Containers for judging your gumbo will be provided by Bandera ProRodeo Association and delivered to your booth by 10:00am. There will be a 2 part ticket on the container, be sure your designated person keeps this when the final sample and ticket container are turned in. Final sample must be turned in **BY** 3:55pm to the Gumbo Cook-Off Chairperson, judging will begin at 4:00pm  
The Winners will be announced February 7, 2026 on stage at 11<sup>th</sup> Street Cowboy Bar around 5:30pm.



**Judging Criteria:** There are 5 criteria that will need to be considered.

Appearance -Looks like a good gumbo roux, color.

Aroma - Should smell appetizing.

Consistency – Thickness of base.

Texture – Balanced quantity of ingredients.

Flavor – Pleasing to the palate.

**Awards:** There will be 5 awards given.

1<sup>st</sup> Place is \$1000

2<sup>nd</sup> Place is \$500

3<sup>rd</sup> Place is \$300

Showmanship Plaque -Will go to the team with the best decorated space.

The Peoples' Choice Plaque -Will go to the team with the most "Taster Choice" tickets.

**Requirements and Safety:**

Area must be kept clean and sanitary during cook-off. Cooking conditions are subject to inspection.

Please no outside food or drinks (except for cooking supplies)

11<sup>th</sup> Street Cowboy Bar will provide all alcoholic and non/alcoholic beverages for sale during this event.

**NO DRINKS OR MARDI GRAS SOUVENIRS TO BE SOLD FROM COOK TEAM LOCATIONS.**

Failure to follow these rules will be grounds for disqualification.

**End Of Day:** Please make sure that your area is clean, and all trash has been removed from your site. There are trash cans located throughout 11<sup>th</sup> Street.

All teams must be off 11<sup>th</sup> Street by 7pm, Saturday, February 7, 2026.
