ADMINISTRATIVE RESPONSIBILITIES

I. Managing Availability

- ▶ Update your calendar bi-weekly (or weekly) in all assigning platforms; we are expecting a large amount of changes due to COVID-19
 - ▶ Game Officials – TGCISOA
 - ▶ Arbiter – BIG 12, Southland, SWAC, WAC, CUSA
 - ▶ Spotfoul – SEC, Sun Belt
- ▶ Note: We do not assign games to people who are blocked.
 - ▶ If you are assigned a game, it is because you showed available. We do not override the system.
 - ▶ Exception is if a board member contacts you get your permission on a date you are blocked.

ADMINISTRATIVE CONTINUED...

II. Accepting/Declining Games

- ▶ TGCISOA Policy is for Referees to Accept/Decline matches within **48 hours**
- ▶ If you have to decline a match, please recommend a replacement
 - ▶ Especially the case if you are declining a match within 72 hours of the game
- ▶ No shows are NOT ACCEPTABLE and will result in severe punishment

ADMINISTRATIVE CONTINUED...

III. Pre-Game Duties

- ▶ Referee
 - ▶ Double check schedules on Assigning Platform and schools websites
 - ▶ Game Location / Date / Time
 - ▶ Expect changes with COVID-19
 - ▶ Contact crew the Monday before each match, or at least 72 hours prior to the match.
 - ▶ Discuss arrival, game time, location, etc.
 - ▶ Get confirmation from all crew members (including assessor if applicable)
- ▶ Assistant Referees
 - ▶ If you don't get an email, phone call, text message, pls initiate the pre-game contact. Please let board member know that Referee failed to contact crew.
- ▶ Arrival → Minimum of 1 hour prior to kickoff
 - ▶ At this time, we expect that locker rooms will not be made available.
 - ▶ For local assigned games, please arrive in game shorts and polo.

IV. Post Game Duties

- ▶ Major Incidents (i.e. Send Offs, major injuries, unruly coaches/spectators, etc.)
 - ▶ Notify board member ASAP (send a text msg) letting them know, to be prepared for "that" phone call from a coach
- ▶ Red Card Reporting
 - ▶ NCAA requires all Red Cards to be reported within 24 hours of match completion
 - ▶ TGICOSA requires that Red Cards are reported same day/evening
 - ▶ Forward copy of the Red Card report to Kyle Phillips and myself.

NCAA RULE CHANGES – MOST MISSED

- Question 7 (11/23)
 - Many marked the answer as Fighting, these are now Violent Behavior II and disciplined differently. Be sure to inform both coaches and scoretable.
- Question 4 (13/23)
 - Coaching staff are permitted to communicate via electronic devices. They must only be "eligible to participate". No coaches serving ejections or game suspensions.
- Question 3 (15/23)
 - The attacking team players can be at least 1 yard from a defensive wall.
