



**ACKNOWLEDGEMENT AND WAIVER OF LIABILITY**

1. Student represents and warrants that (s)he is in good health and has no physical or mental disability, impairment, or pre-existing condition that may otherwise prevent him/her from safely participating in the listed program’s activities. Student acknowledges the advice of **WOLFONE PRODUCTIONS / KID POWER JU-JITSU** that everyone should receive a physical examination prior to participating in any strenuous physical activity.
