CONTESTANT RULE FORM

SATURDAY, AUGUST 15TH, 2026@ 7:00 p.m.

1. Contestants must be between 16-20 years old at the time of pageant. **Contestants may not be turning 21 by December 31, 2026. This will make them ineligible to compete in the State pageant in January 2027**
2. Contestants must be sponsored by a business, individual sponsor or organized club.
3. Sponsor may only sponsor **ONE** contestant in each age group.
4. **EARLY ENTRY FEE IS \$25.00 IF POSTMARKED BY JULY 3RD, 2026 – ENTRY FORMS POSTMARKED AFTER JULY 3RD, 2026 REQUIRE AN ENTRY FEE OF \$35.00.**
5. **ENTRY DEADLINE IS JULY 22ND, 2026 FOR ANY PICTURES TO BE IN THE PAPER,**
6. **TWO 2X3 SCHOOL TYPE PHOTOS MUST BE INCLUDE FOR THE NEWSPAPERS. EITHER MAILED WITH ENTRY FORM OR THEY CAN BE EMAILED TO scottcofof@gmail.com, but must include child's name, age group, and parent's names as they want them to appear in the paper. NO LATE PHOTOS CAN BE ACCEPTED IF YOU WANT THEM TO APPEAR IN THE PAPER.**
7. Contestants must be residents of Scott County and provide a 911 address.
8. Previous winners are not allowed to compete in the same age category again.
9. **DRESS CODE: Long Evening Wear-Garment must not expose midriff area.**
10. **NO CELL PHONES ALLOWED BACKSTAGE DURING THE DURATION OF THE PAGEANT.**
11. Contestants must be and have been born a female.
12. Contestants are judged on: Beauty 50% Personality 25% Interview 25%
13. Only **ONE** chaperone per contestant backstage until pageant time. The chaperone will be asked to leave backstage at least 20 minutes prior to the start of the pageant.
14. During the parade of beauty, each contestant will be required to introduce themselves.
15. Photogenic Contest is voluntary – It requires an additional \$5.00 entry fee & a 5X7 photo.
16. Completed entry form with sponsor fee postmarked no later than July 22nd, 2026. **CASH OR MONEY ORDER- NO CHECKS. Entry forms with missing or incomplete information will not be accepted.**
17. Practice will be held on SUNDAY, AUGUST 9th, 2026 @ 2:30 P.M.
18. The decision of the judges is final.
19. The Scott County Fair Board and Scott County Fairest of the Fair Board are not responsible for **ANY** lost or misplaced items or any accidents that occur related the pageant or on Fair grounds.
