1. Contestant must be **13, 14 or 15** years old. (Cannot be 16 years old when appearing on stage).
2. Contestant must be sponsored by a business, individual sponsor, or organized club.  
(1 sponsor per contestant).
3. Sponsor may sponsor **one** contestant in each category.
4. Entry fee is **\$25.00** per contestant.
5. Contestant must provide a Scott County 911 address & must be a legal resident of Scott County.
6. Previous winners are not eligible to compete in same category.
7. Dress code: **Long Evening Wear – Garment cannot expose midriff area.**
8. Contestants are judged on: **Beauty – 75%      Poise & Personality – 25%**
9. All parents and/or adult chaperons must leave the Dressing Area at least 20 minutes prior to the beginning of the pageant.
10. **Two pictures (school-type only) must be attached for the newspaper.**
11. Contestants **MUST MAIL** a completed Entry Form accompanied by a \$25.00 sponsor fee (**CASH OR MONEY ORDER ONLY – no personal checks will be accepted**), this Contestant Rule Form signed by parent or guardian and 2 school-type pictures. **ENTRY FORMS WITH MISSING OR INCOMPLETE INFORMATION WILL NOT BE ACCEPTED!**
12. **NEW CATEGORY: Photogenic Additional \$5.00 Entry Fee

13. Entry deadline is **July 23, 2021** (postmark of July 23rd is acceptable)
14. Practice will be on 8/8/21 at 4:00 p.m. at the Scott County Fair grounds.

16. During parade of beauties – Contestants will be announcing themselves.
