1. Contestant must be 4, 5 & 6 years old.
2. Contestant must be sponsored by a business, individual sponsor, or organized club.
3. Sponsor may sponsor one contestant in each category.
4. **Early Entry Fee** is \$25.00 if postmarked by July 8th after July 8th entry fee is \$35.00.
5. **ENTRY DEADLINE IS JULY 22ND 2022 -(POSTMARKED BY JULY 22ND IS OK)**
6. Contestant must be a resident of Scott County and provide a 911 address.
7. Previous winners are not allowed to compete in the same age category.
8. Dress code: **Short Pageant Wear-Garment cannot expose midriff area.**
9. Contestants are judged on: **Beauty-75% Poise & Personality – 25%**
10. All parents and/or adult chaperones must leave the dressing area at least 20 minutes prior to the beginning of the pageant.
11. Photogenic Contest – Additional \$5.00 entry fee & a 5x7 photo.
12. **Two pictures (school type) must be attached for newspapers.**
13. Contestant must mail completed Entry Form with sponsor fee (**Cash or Money Order only**), this Contestant Rule Form signed and 2 school type photos. Entry forms with missing or incomplete information will not be accepted.
14. Practice will be on Thursday, August 4th @ 6:00 p.m.
15. The decision of the judges is final.
