1. Contestants must be between 0-12 years old at the time of pageant.
2. Contestants must be sponsored by a business, individual sponsor or organized club.
3. **There is NO entry fee but ENTRY DEADLINE IS JULY 22ND, 2026 FOR ANY PICTURES TO BE IN THE PAPER,**
4. **TWO 2X3 SCHOOL TYPE PHOTOS MUST BE INCLUDE FOR THE NEWSPAPERS. EITHER MAILED WITH ENTRY FORM OR THEY CAN BE EMAILED to scottcofof@gmail.com , but must include child's name, age group, and parent's names as they want them to appear in the paper. NO LATE PHOTOS CAN BE ACCEPTED IF YOU WANT THEM TO APPEAR IN THE PAPER.**
5. Contestants must be residents of Scott County and provide a 911 address.
6. Previous winners are not allowed to compete in the same age category again.
7. **DRESS CODE: Sunday Best or Pageant Wear**
8. Contestants are judged on: Beauty 50% Personality 50%
9. Each contestant can have **ONE** chaperone per contestant backstage for the duration of the pageant. Chaperones are asked to wear navy, black or khaki color. No spaghetti straps, short dresses or exposed midriff areas.
10. Photogenic Contest is voluntary – It requires a 5X7 photo.
11. Completed entry form with sponsor postmarked no later than July 22nd, 2026.
12. The decision of the judges is final.
13. The Scott County Fair Board and Scott County Fairest of the Fair Board are not responsible for **ANY** lost or misplaced items or any accidents that occur related the pageant or on Fair grounds.
