2. Contestant must be sponsored by a business, individual sponsor, or organized club.
3. Sponsor may only sponsor **ONE** contestant in each age group.
4. **EARLY ENTRY FEE IS \$25.00 IF POSTMARKED BY JULY 15, 2025 – ENTRY FEE POSTMARKED STARTING JULY 16, 2025 IS \$35.00**
5. **ENTRY DEADLINE IS AUGUST 5, 2025.**
6. Contestant must be a resident of Scott County and provide a 911 address.
7. Previous winners are not allowed to compete in the same age category.
8. Dress Code: **PAGEANT WEAR**
9. Contestants are judged on: **Beauty 50% Poise & Personality 50%**
10. Only one chaperone per contestant.
11. Photogenic Contest – Additional \$5.00 entry fee & 5x7 photo
12. **TWO 2X3 SCHOOL TYPE PHOTOS MUST BE INCLUDED WITH ENTRY FORM FOR NEWSPAPERS. NO LATE PHOTOS CAN BE ACCEPTED.**
13. Completed entry form with sponsor fee postmarked by August 5th, 2025. **CASH OR MONEY ORDER.** Entry forms with missing or incomplete information will not be accepted.
14. Practice will be on **SATURDAY, AUGUST 16TH, 2025 AT 9:00 A.M.**
15. Chaperones are required to wear **SOLID BLACK OR NAVY CLOTHING- NO SPAGHETTI STRAPS, DRESSES OR EXPOSED MIDRIFF AREAS.**
16. The decision of the judges is final.
17. The Scott County Fair Board and Scott County Fairest of the Fair Board are not responsible for any lost or misplaced items or any accidents.
