1. Contestants must be 2 & 3 years old at time of pageant.
2. Contestant must be sponsored by a business, individual sponsor or organized club.
3. Sponsor may sponsor only one contestant in each age category.
4. **Early Entry Fee** is \$25.00 if postmarked by July 12th, 2024- Entry fee is \$35.00 after July 12th, 2024.
5. **ENTRY DEADLINE IS AUGUST 2ND, 2024**
6. Contestant must be a resident of Scott County and provide a 911 address.
7. Previous winners are not allowed to compete in the same age category.
8. Dress code: **PAGEANT WEAR**
9. Contestants are judged on: **Beauty- 50% Poise & Personality-50%**
10. All parents/chaperones must leave the dressing area at least 20 minutes prior to the beginning of the pageant.
11. Photogenic Contest – Additional \$5.00 entry fee and 5x7 photo
12. Two school type pictures must be attached for newspapers
13. Completed entry form with sponsor fee by August 2nd, 2024 (**Cash or Money Order only**)
14. Entry forms with missing or incomplete information will not be accepted.
15. Practice will be on TUESDAY, AUGUST 13TH @ 6:30 p.m.
16. Chaperones are required to wear **SOLID BLACK OR NAVY CLOTHING-NO SPAGHETTI STRAPS, DRESSES, OR EXPOSED MIDRIFF AREAS.**
17. The decision of the judges is final.
