1. Contestant must be 16, 17, 18, 19 or 20 years old. \*\* Contestants may not be turning 21 by December 31, 2024- it will make them ineligible to compete in the State Pageant in January 2025.
2. Contestant must be sponsored by a business, individual sponsor, or organized club.
3. Sponsor may sponsor only one contestant in each category.
4. **Early Entry Fee** is \$25.00 if postmarked by July 12th after July 12<sup>th</sup> entry fee is \$35.00
5. **ENTRY DEADLINE IS AUGUST 2<sup>ND</sup>, 2024**
6. Contestant must be a resident of Scott County and provide a 911 address.
7. Previous winners are not allowed compete in the same age category.
8. Dress code: **Long Evening Wear**
9. Contestants must be and have been born a female.
10. Contestants are judge on: **Beauty-50% Poise & Personality-25% Interview 25%**
11. All parents and/or adult chaperones must leave the dressing area at least 20 minutes prior to the beginning of the pageant.
12. During the parade of beauties each contestant will be required to introduce themselves.
13. **NO CELL PHONES** will be allowed with contestants during the duration of the pageant.
14. Photogenic Contest- Additional \$5.00 entry fee and 5x7 photo.
15. Two pictures (school type) must be attached for newspapers.
16. Contestants must mail completed Entry Form with sponsor fee by August 2<sup>nd</sup>, 2024(**Cash or Money order only**). **Entry forms with missing information will not be accepted.**
17. Practice will be on Sunday, August 11<sup>th</sup> @ 4:00 p.m.
18. The decision of the judges is final.
