1. Contestants must be between 10-12 years old at the time of pageant.
2. Contestant must be sponsored by a business, individual sponsor, or organized club.
3. Sponsor may only sponsor **ONE** contestant in each age group.
4. **EARLY ENTRY FEE IS \$25.00 IF POSTMARKED BY JULY 15, 2025 – ENTRY FEE POSTMARKED STARTING JULY 16, 2025 IS \$35.00**
5. **ENTRY DEADLINE IS AUGUST 11, 2025. (To be in the paper)**
6. Contestant must be a resident of Scott County and provide a 911 address.
7. Previous winners are not allowed to compete in the same age category.
8. Dress Code: **Long Evening Wear-Garment must not expose midriff.**
9. Contestants must be and have been born a female.
10. Contestants are judged on: **Beauty 50% Poise & Personality 50%**
11. All parents/chaperones must leave the dressing area at least 20 minutes prior to the beginning of the pageant.
12. During the parade of beauties, each contestant will be required to introduce themselves.
13. **NO CELL PHONES** will be allowed with contestants during the duration of the pageant.
14. Photogenic Contest – Additional \$5.00 entry fee & 5x7 photo
15. **TWO 2X3 SCHOOL TYPE PHOTOS MUST BE INCLUDED WITH ENTRY FORM FOR NEWSPAPERS. NO LATE PHOTOS CAN BE ACCEPTED.**
16. Completed entry form with sponsor fee postmarked by August 11<sup>th</sup>, 2025. **CASH OR MONEY ORDER** -Entry forms with missing or incomplete information will not be accepted.
17. Practice will be on **Saturday, August 24<sup>th</sup>, 2025 AT 1:00 P.M.**
18. The decision of the judges is final.
19. The Scott County Fair Board and Scott County Fairest of the Fair Board are not responsible for any lost or misplaced items or any accidents.
