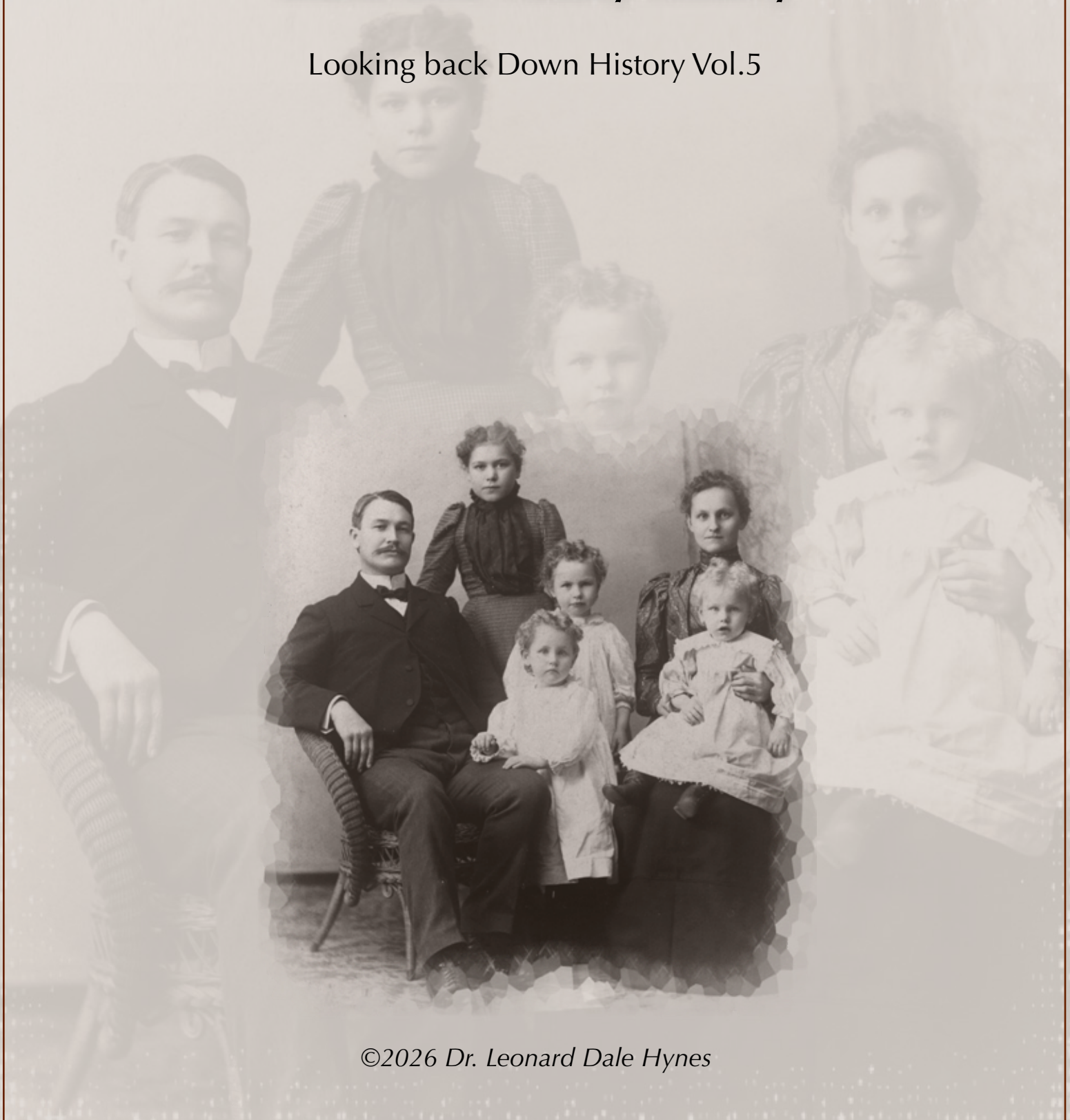

A Memorial Service will be held on Thursday, March 24 at 2 pm.

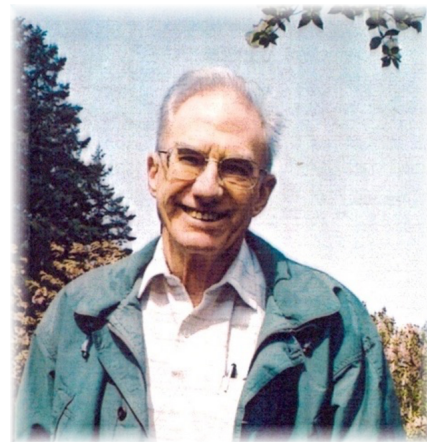

This is a letter written by Robert's daughter Hilda in a reply to a letter about her parents background. Dated October 3 1999.

I believe my dad came to Canada because of the conditions in England had deteriorated and maybe work was scarce and Canada was the place to make ones fortune.

I believe dad came in 1909. It was about a year before mom came, and she came in 1910. He would be 26 years old.

He came to Winnipeg first. Mom had a half brother there, Alfred Turner. Uncle Arthur, moms brother, was living in Winnipeg with uncle Alf, and I imagine encouraged dad to come to Canada. Just how long he was there I don't know because uncle Arthur and dad were in Victoria when mom came out in 1910.

He worked at a rice mill in Victoria. He and mom were engaged before he left England and I imagine they met in Ashford as thats were mom lived before coming to Canada.

Mom came to Canada to get married. Mom arrived in May 1910 and came to Victoria. She was 29 years old. They were married in September 1910. She was a book keeper, worked in an office.

We lived in Victoria. I believe we went to Bevan in 1920 or 1921 and dad worked in a grocery store there, but it didn't last long. Margaret was born in Cumberland in October 1921. We moved to a little villiage of Sandwick. Times were hard and I don't know wether dad was working then. We moved to Courtney and dad worked in a grocery store there. He was persuaded to start and sell Rawleigh products while in Courtney, so we moved to Qualicum beach (about 1924). We lived in Qualicum a few months and moved to Port Alberni in the fall of 1924. Phil was born in Port Alberni in July 1925, then moved to Naniamo in 1942.

As for hobbies dad liked to lawn bowl in later years. Mom loved to garden, knit, and both enjoyed a seniors group. While the family was growing up there wasn't finances to do extra activities. Our home was their hobby. Things were not easy most of their married lives.

I don't know much about my grand parents. They lived in England. My mom's mother came to Canada with her, as she was widowed and I guess she had no one to care for her in England. Mom's mom had married a widower with four children, Alf Turner, Caleb Turner, Annie Turner and Jane Turner (Wells). Uncle Arthur and mom came from this union. Mom's mom used to do upholstery after being widowed. I believe mom's father did carpentry.

Dad's parents lived in Liverpool I believe. They also had a woolen mill in Pandy in Wales.

Eleanor died at Cartref (cottage?) # 113 The Grove in West Wickham, Kent England. According to Joan Robertson Howlett, Eleanor was a VERY domineering Matriarch, she wanted her children to stay close to home. This is said to be the reason that the three daughters never married, until Nellie married after her mothers death. Joan's father William was also "run" by his mother. He had the opportunity to continue on to grammar school, but "MOTHER" said he had to stay close to home. This ended up with him going into the family business 'paper making', which William hated!

Moved to Pandy mill in 1860 from Abermule, Newtown, Montgomeryshire Wales with wife. William was a weaver by trade.

From an article in "The Chronicle" Saturday, March 29, 1952

"Early in the year 1860 a Mr. William Evans and his wife came to Pandy Mills from Abermule, Newtown, Montgomeryshire. He appeared to have little school education - being apparently a self taught man. This being so in particular to his trade he knew the technical part of the industry even better than if he had received college training.

He made his own dyes of various shades and colours from vegetable matter obtained chiefly off the Pandy land, such as Elderberry Walnut (both from the nut and the leaf) lichens Bracken and the bark of various trees. He did not approve of any of the artificial dyes and never used them. When he died in 1909 his own dyes were still being used. He also had a secret of his own of making a certain twist in the yarn which he claimed added greatly to the strength of the cloth. Once it is said, he challenged a man to tear a piece of cloth for a gold sovereign. The man failed.

His son William Moses Evans took over the mill and the same method of dyeing was continued right up to the time when the mill closed down in the year 1933. The goods chiefly manufactured at the mill were tweeds, cloths, yarns, and blankets (all hand woven) and were noted far and wide for their long wearing qualities and gained many prizes and medals at various exhibitions and Royalty had been supplied on two or three occasions. An old weaving machine from the factory can be seen today at the National Museum of Wales in Cardiff."

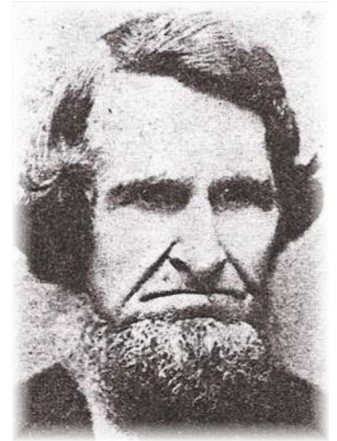

Her goods were located in the houses of her son, Richard Weller and her son-in-law, Alexander Couchman. She bequeathed chests, other household goods, ¹110 and pewter to her three daughters,

Agnes Baseden, Elizabeth Couchman and Catherine Denwood. She left her son, Richard, pewter, woodwork household stuff, a featherbed and its bedding, a carpet, brand-irons and two woollen coverlets. Her brother-in-law, William Weller was bequeathed a cloak and 10 shillings and her sons, Dence, Stephen, John and Alexander also each received 10 shillings. She stated that the goods bequeathed to her daughters should be sold when her daughters and their husbands had died and the proceeds given to their children.

James Lewes (d. c. 1599) of Abernantbychan in the parish of Penbryn, Cardiganshire, was the son of Lewes David ap Meredydd (fl. 1542-1564) of Penbryn. By his first marriage James had one son, also called James Lewes, the founder of the Lewes family of Gellidywyll in the parish of Cenarth, Carmarthenshire. Abernantbychan and most of his father's lands passed to the eldest son of the second marriage, Sir John Lewes (fl. 1601-1652). The Lewes family retained possession of the Gellidywyll estate until the family failed when Thomas Lewes and his brother John Lewes (1743-1795) died of West Indian fever within days of each other. Gellidywyll was inherited by a distant cousin, William Owen Brigstocke (1761-1831) of Blaen-pant in the parish of Llandygwydd, Cardiganshire, and was eventually sold by his grandson, William Owen Brigstocke, to Lord Cawdor.

lawyer and diplomat , was the son of Howel Carne of Nash and a descendant of the princes of Gwent .
Educated at Oxford (where he graduated B.C.L. 1519 , D.C.L. 1524), he became principal of Greek Hall in 1521 .

In 1530 he was attached in a legal capacity to the embassy of the earl of Wiltshire (Anne Boleyn 's father) to explain to Charles V at Bologna the king 's reasons for repudiating Catherine of Aragon ;
thence he accompanied Bonner to Rome on legal business concerning the 'divorce' (on which see S.P. Hen. VIII , vii, 269 n. and Harpsfield , More , in E.E.T.S. , 1932 , 223).

On a later mission to Bologna (1534), he was charged with the appeal 'from the Bishop of Rome ill-informed and in fear of the imperialists to the Bishop of Rome better informed and in more liberty.' On his return he served as commissioner for dissolving monasteries (1538-9), purchasing Eweny priory (which he had leased in 1536) on its dissolution (1545).

In 1538-9 he was sent to the Netherlands in pursuance of the king's suit for Anne of Cleves , and in 1540 to France (probably with a knighthood) to announce the dissolution of this marriage, returning to the Netherlands on commercial mission in 1541 .

Henry rewarded him with the chancellorship of Salisbury and an English sinecure rectory, but disappointed him of a Welsh living in commendam ;

Pope Clement VII gratified him with a personal indulgence and one on behalf of the chapel of Holy Cross , Cowbridge , during Carne 's lifetime; the tradition that he owed his knighthood to the emperor seems to be unfounded.

Under the Act of Union he became first sheriff of Glamorgan (1542), and his name appears in the county muster for the Boulogne campaign in 1544 , but he spent the entire period of the siege as resident ambassador in Brussels .

He was in retirement under Edward VI , save for membership of the Council of Wales (c. 1551) and occasional consultation on diplomatic issues .

Under Mary he served a second term as sheriff (1554), and as M.P. for Glamorgan (1554) he provided the first known example of the committal of a Welsh bill to a Welsh member; he was also on the commission that declared the illegality of bishop Bonner 's deposition by Cranmer (1553).

Another mission to the emperor (1553) was followed by a complimentary errand, which turned into a permanent embassy, to Rome — our only independent representation abroad during the reign.

Shortly before Mary 's death he asked for his recall, but arrangements for his replacement by Thomas Goldwell , bishop of S. Asaph , were interrupted by the demise of the Crown .

He repeated the request on Elizabeth 's accession, but was instructed to stay at his post, without committing the Government , till a decision should be reached on relations with Rome .

Till Feb. 1559 , when he was officially recalled, he was sending reports on the friendly dispositions of Rome and Spain and warnings against France .

The pope refused passports for his return, and conferred on him the wardenship of the English Hospital , to which he appears to have been previously nominated by Mary , but which he later resigned to Goldwell .

On his death in 1561 his friends Geoffrey (or Griffith) Vaughan and Thomas Freeman erected a monument to his memory at the church of SS. Andrew and Gregory in Rome (photograph, text, and commentary in Reports and Trans. Cardiff Naturalists' Soc. , lxxx, 12-15).

This was defaced by the French in 1798 but restored through the good offices of the Rev. J. M. Traherne (q.v.) , chancellor of Llandaff , fifty years later.

The inscription supports the suggestion (cf. Cal. S.P. Rome , i. 27, pp. 15, 16) that his detention in Rome was not unwelcome, since its 'involuntary' character saved his Glamorgan estates — swollen since 1537 by his marriage to the widow of Sir John Raglan — for his son THOMAS CARNE , who, although a recusant (as were many of the family till well on in the next cent.), was twice M.P. and thrice sheriff for his county.

There is some debate as to the origins of the Malenfant/Maliphant name and because of its uniqueness, there are several people who have researched its origins, some believing that they came over from France with William the Conqueror at the Battle of Hastings, but only some 20 named individuals are known to have been at the battle and the Malenfants/Maliphants weren't amongst them! There is however a possible French connection since a tax roll of 1195 shows one Thomas Malenfant at Ambrieres in France, on the border between Normandy and Anjou.

Surnames became necessary when governments introduced personal taxation. In England this was known as Poll Tax. Throughout the centuries, surnames in every country have continued to "develop" often leading to astonishing variants of the original spelling. The first record of a Malenfant in England is a Geoffrey Malenfant paying a fine in 1206 to the Sheriff of Norfolk and Suffolk and since the Earl of Pembroke's appointment in 1138 had links with Suffolk then the arrival of the Malenfants in Wales might have some geographical links to Suffolk. There were also Malenfants in Ireland in 1169, which could be another clue, but otherwise we have no idea exactly when Malenfants came to Wales, The first Malenfant we hear of in Wales is Walter, who was killed fighting the Welsh outside Cilgerran in 1258.

There were other lines of Malenfants, notably around Kidwelly in Carmarthenshire, where there was a

Henry Malenfant as early as 1313. These Malenfans seem more involved in trade and the church than politics, but most if not all modern Maliphants are descended from another Henry Malephant whose death in 1591 is recorded in the miraculously surviving parish register for St Ishmael, in the next parish to Kidwelly, the town where many Maliphants still live.

Some attribute the name to have been derived from the French mal enfant (naughty child), but why such a name would have been adopted is unclear as is the fact that the name (albeit with a few spelling variations) was relatively widely recorded, particularly in Wales. An alternative suggestion is that the origination may have been theatrical for someone who played the part of a "Malle Enfant" in the travelling theatres, during the three hundred years from 1066, when French was the "official" language of England. However, the "Welsh" connection may have a part to play, "Mal" in medieval Welsh meant a mill, a place of grinding, and this plus the Norse personal name "Oleifr", which by 1317 had transposed to "Olofaunt", may explain the Welsh recordings as "The Mill of Oleifr", a topographical name.
