

Central to that vision was his passionate belief in and advocacy for higher education for aboriginal people.

This Scholarship Fund is dedicated to helping realize Joe's dream of providing post-secondary opportunities for energetic, dedicated and aspiring British Columbia First Nation students to enable them to realize their dreams of becoming leaders of tomorrow in the career of their choosing. There is no more appropriate tribute to the work of Chief Mathias than to witness the success of the young aboriginal graduates and scholarship recipients presented here. First Nation doctors, businessmen and women, scientists, social workers, engineers, nurses, computer programmers, lawyers, and teachers...these are the leaders of the future who will continue his legacy and ensure a bright and prosperous future for First Nations citizens and their communities.

The Chief Joe Mathias Scholarship has provided over 500 scholarships to over 100 students from most of the First Nations in BC since its inception in 2002.


Aiden Antoine

Brendan Eshom


**Gitga'at (Hartley Bay) Bachelor


Joshua Houghton



Sophie Pierre was born and raised in ʔaq'am near Cranbrook, B.C., and has lived there all her life. Pierre served as the elected chief of ʔaq'am, formerly known as the St. Mary's Indian Band, a member of the Ktunaxa Nation for 26 years, and Ktunaxa Nation Council's tribal chair for 25. Among her defining accomplishments was the transformation of a residential school, where she studied as a child, into the renowned St. Eugene Mission Resort. She was appointed chief commissioner of the B.C. Treaty Commission in 2009 and received the Order of B.C. in 2002 and the Order of Canada in 2016.

Melody Morrison

Melody Morrison has worked with First Nations and Indigenous organizations across the country for several decades. She provides strategic, government relations and communications advice, writes and mentors young leaders. Presently, Melody works with the Kaska Nation in British Columbia and the indigenous Leadership Initiative in support of advancing Indigenous led-conservation efforts like Indigenous Conserved and Protected Areas (IPCA's) and the Indigenous Guardians movement, 'Land Needs Guardians.' Angela Wesley


