Each shipment of semen will be charged \$400. By signing this contract you agree to allow Matt Shiflet Stables Inc. to charge your credit card for all charges associated with the shipment of fresh cooled semen.

1. This mare is booked by name. The booking is valid to the mare named and may not be transferred to any other mare without the consent of the Stallion Owner. The contract may not be sold by the mare owner.
2. No mare shall be bred until breeding contract is signed, returned and stud fee is paid in full.
3. Board will be charged at a rate of \$ 25 per day (mare) or \$ 30 (mare with foal).
4. Mare owner agrees to pay all veterinarian and farrier services incurred while mare is at Matt Shiflet Stables and authorizes Matt Shiflet Stables to obtain these services for said mare as deemed necessary by Matt Shiflet Stables Inc.
5. All charges for board, veterinary services, farrier services, and related fees are to be paid monthly by the mare owner. All charges and fees must be paid in full prior to the mare's departure from the farm. A failure to pay in full will result in a withholding of the breeder's certificate.

6. Mare owner agrees that pregnancy examinations shall be authorized as deemed necessary by the stallion owner or the licensed veterinarian then in attendance. If any special veterinary services are required or desired by the mare owner this shall be specified in writing to the stallion owner.

7. Neither the stallion owner, manager, farm nor its members, agents, or employees shall be liable for injury, death, nor disability suffered by the mare, from any cause whatsoever, while in the custody of Matt Shiflet Stables Inc.

8. In the event that the above named mare does not conceive, gives birth to a dead foal, or fails to produce a live foal (stands and nurses), then a return privilege is granted for the above named mare. **This return privilege extends for the next breeding season only.**

9. If the above named stallion is deceased, or the Stallion Owner is otherwise unable to provide semen from such stallion during the time the return privilege is valid (one year from the signing of the contract), then the service fee shall be refunded.

9. Return privileges are natural cover and fresh cooled semen only. Frozen semen will not be provided on return privilege.

10. In the event that the above named mare produces twins or the mare is flushed for embryos and the result is twins which are implanted and carried to term then an additional stud fee of \$ ___5000___ is due at the time of foaling of the twin or multiple birth.
