Stallion Service Contract

Stud Fee: \$ 5000

Fee schedule as follows: **A \$1500 NONREFUNDABLE fee** to be paid in full before first shipment of semen. At time of foaling the remaining balance of \$3500 is due. Failure to pay the remaining balance of stud fee within (10 days) of foaling will result in an additional \$1000 fee every 30 days from foaling until paid in full. Breeders Certificate will be held and foal unable to be registered until stud fee is paid in full. There is NO RETURN SERVICE offered.

Each shipment of semen will be charged \$500. By signing this contract you agree to allow Matt Shiflet Stables Inc. to charge your credit card for all charges associated with the shipment of fresh cooled semen.

1. This mare is booked by name. The booking is valid to the mare named and may not be transferred to any other mare without the consent of the Stallion Owner. The contract may not be sold by the mare owner.
2. No mare shall be bred until breeding contract is signed, returned and stud fee is paid.
3. Board will be charged at a rate of \$ 30 per day (mare) or \$ 35 (mare with foal).
4. Mare owner agrees to pay all veterinarian and farrier services incurred while mare is at Matt Shiflet Stables and authorizes Matt Shiflet Stables to obtain these services for said mare as deemed necessary by Matt Shiflet Stables Inc.
5. All charges for board, veterinary services, farrier services, and related fees are to be paid

monthly by the mare owner. All charges and fees must be paid in full prior to the mare's departure from the farm. A failure to pay in full will result in a withholding of the breeder's certificate.

6. Mare owner agrees that pregnancy examinations shall be authorized as deemed necessary by the stallion owner or the licensed veterinarian then in attendance. If any special veterinary services are required or desired by the mare owner this shall be specified in writing to the stallion owner.

7. Neither the stallion owner, manager, farm nor its members, agents, or employees shall be liable for injury, death, nor disability suffered by the mare, from any cause whatsoever, while in the custody of Matt Shiflet Stables Inc.

8. In the event that the above named mare does not conceive, gives birth to a dead foal, or fails to produce a live foal (stands and nurses) there is no return service and no refund of the \$1500. This contract is only good for the 2024 Breeding Season.

9. If the above named stallion is deceased or becomes unable to provide shipments of semen there will be no refund of the \$1500 fee after the first shipment of semen. No use of frozen semen will be granted at any point.

10. In the event that the above named mare produces twins or the mare is flushed for embryos and the result is twins which are implanted and carried to term then an additional stud fee of \$ 5000 is due at the time of foaling of the twin or multiple birth.
