- 10. <u>If Meeting attendee/participants (Institution/NGO's)</u> then Air Ticket, copy of inviter's passport/national id, residence permit, invitation letter, certificate of registration of Tanzanian Company
- 11. <u>If visiting spouse/family reunion</u> then Air Ticket, copy of inviter's passport/national id, residence permit, invitation letter, proof of relationship like marriage/birth certificate

- 7. If travelled previously to Tanzania, then date of last visit and visa number
- 8. <u>If Director of company registered in Tanzania</u>, then proof of directorship along with certificate of incorporation or compliance issued in Tanzania
- 9. <u>If Regular family visit</u>, then letter of invitation, Passport or National ID of a host citizen/Resident Permit for Tanzanian resident and copy of birth or marriage certificate of applicant
- 10. <u>If visiting for consultancy with registered company in Tanzania</u>, then copy of Contract for Service along with invitation letter, certificate of incorporation/compliance of Tanzania company
- 11. <u>If visiting for consultancy with registered company in Tanzania,</u> then copy of Contract for Service along with invitation letter, certificate of incorporation/compliance of Tanzania company
- 12. If visit is related with bilateral agreement, then letter of invitation
- 13. If any other reason, then invitation letter and documents that justify the reason

Important Notes:

- 1. Additional Documents or Information may be needed based on Purpose of Visit
- 2. Maximum documents and Information will have maximum Chances of Visa Approval as Visa Charges once Paid are Non-Refundable in case of Delay or refusal
- 3. For Multiple Entry Visa Any other evidence to prove that the applicant is bound to travel frequently into the United Republic of Tanzania.
