UAE (Dubai) Short Stay Visa for Indian National

Kindly note the below updates from UAE Immigration for Indian National holding Indian Passport

Indian nationals with the following documentation can obtain a visa on arrival for a maximum stay of 14 days for a charge of AED120. They can also apply to extend their stay for an additional 14 days for AED250.

- Visit visa issued by the USA
- Green card issued by the USA
- Residence visa issued by the UK
- · Residence visa issued by the EU

The Indian Passport, US Visa, US Green Card, the UK Resident Permit and the EU resident permit must be valid for at least six months.

Note: We will recommend to recheck with carrier airline about eligibility for "Visa On Arrival" and permission to board

We can arrange Tourist/Visit Visa through Sponsor in UAE if you are not eligible for "Visa On Arrival" or want Visa Prior to Travel

Travellers are required to have below documents in their possession before arrival in Dubai.

- Health declaration form (provided by carrier airline)
- Quarantine undertaking form (provided by carrier airline)
- All passengers arriving in Dubai from any destination, including passengers connecting in Dubai, must have a negative COVID-19 test certificate to be accepted on the flight. The test must be taken a maximum of 48 hours before departure. This excludes children under the age of 12 and passengers who have a moderate or severe disability. You can visit https://www.icmr.gov.in/ for list of authorised labs in India.
- Health insurance valid for the duration of the visa validity.
- Any other guidelines and requirements by carrier airline (please check before departure).
- UAE Visit and Tourist visa holder should travel with confirmed return air ticket and 2000
 Dirhams to avoid risk of being deported

UAE Visa issued through us is valid for Business, Tourist, Conference, Family Visit or any other Short Term Visit and cannot be converted or extended into any other category like Employment, Study, Dependent.

Types of UAE Tourist Visas: -

- 1) 48 Hours Stay Transit Visa: This Visa is valid for 30 Days from date of issue to Enter and Suitable for Stay upto 48 Hours from time of Arrival while Transiting from Dubai (Only for Entry and Exit from Dubai by Any Airline)
- 2) <u>96 Hours Stay Transit Visa</u>: This Visa is valid for 30 Days from date of issue to Enter and Suitable for Stay upto 96 Hours from time of Arrival while **transiting from Dubai** (Only for Entry and Exit from Dubai by Any Airline)
- 3) <u>96 Hours Stay Visa:</u> This Visa is valid for 30 Days from date of issue to Enter and Suitable for Stay upto 96 Hours from time of Arrival in Dubai (Applicable only for Emirates and Fly Dubai Passenger with return Ticket)
- 4) 14 Days Stay Single Entry Service / Business Visa (Currently not issued by UAE Immigration):
 This Visa is valid for 58 Days from date of issue to Enter and suitable for 14 days stay availed by travelers having a Shorter stay in UAE purely for business purpose. This type of Visa is preferred by travelers going to UAE for Business meetings, Short Training, Conference, etc (Travel by Any Airline anywhere in UAE)
- 5) 30 Days Single Entry Visa (Tourist/Single Short): This Visa is valid for 58 Days from date of issue to Enter and Suitable for 30 days stay availed by travelers having a Shorter stay in UAE. This type of Visa is preferred by travelers going to UAE for holidays, visit family / friends or for business, conference, etc. (Travel by Any Airline anywhere in UAE)
- 6) 30 Days Multiple Entry Visa (Tourist/Multi-Short): This Visa is valid for 58 Days from date of issue to Enter and Suitable for 30 days stay availed by travelers having a Shoter stay and travelling multiple times to UAE. This type of Visa is preferred by travelers going to UAE for holidays, visit family / friends or for business etc. (Travel by Any Airline anywhere in UAE)
- 7) 90 Days Single Entry Visa (Long Term Visit Single Entry Tourist): This Visa is valid for 58 Days from date of issue to Enter and Suitable for 90 days stay availed by travelers having a longer stay in UAE. This type of Visa is preferred by travelers going to UAE for holidays, visit family / friends or for business trainings etc. (Travel by Any Airline anywhere in UAE)
- 8) 90 Days Multiple Entry Visa (Long Term Visit Multiple Entry- Tourist): This Visa is valid for 58 Days from date of issue to Enter and Suitable for 90 days stay availed by travelers having a longer stay and travelling multiple times to UAE. This type of Visa is preferred by travelers going to UAE for holidays, visit family / friends or for business trainings etc. (Travel by Any Airline anywhere in UAE

- 1. For 48/96 Hours transit visa Entry and Exit must be from Dubai Airports
- 2. Applicant must not had overstayed during previous visit or involved in any criminal or unwanted activities.
- 3. Applicant must not have valid UAE visa at the time of applying new visa
- 4. Visa Code EK48, EK96, EK30S, EK90S, EK30M & EK90M will be processed only between Mon and Fri excluding any national Holiday.
- 5. Visa Codes ALL48, ALL96, ALL30S-DS, ALL30S-ADS, ALL90S, ALL30M & ALL90M will be processed between Mon and Sat excluding any national Holiday.
- 6. Visa Request for Visa Codes ALL48, ALL96, ALL30S-ADS, ALL90S, ALL30M & ALL90M received after 2pm on Saturday will be processed only on Monday.
- 7. Visa Request for Visa Code ALL30S-DS received after 5pm on Saturday will be processed only on Monday (On request can be processed on Sunday with INR 354 additional fees)
- 8. Please check with Carrier Airlines about travel guidelines before boarding
- 9. UAE Immigration is closed on every Friday and Saturday in addition to any UAE National Holiday.
- 10. Dubai Visa Processing Centre in India is closed on Sunday and Indian National Holidays
- 11. Preferred Time for Normal Visa request is 9 am to 4pm from Monday to Friday and 9am to 2pm on Saturday.
- 12. Preferred Time for Express Visa request is 9 am to 11am on all Working Day of Dubai Processing Centre in India for faster processing of visa.
- 13. All Visa Charges are non-refundable in case of Visa Refusal, Rejection, Delay in visa process by UAE (Dubai) Immigration due to any reason
- 14. Murugan Travels, Murugan Airvoyz or its Partners takes no responsibility for any delay or refusal in visa for any reason by UAE (Dubai) Immigration
- 15. The decision to grant or refuse a visa is the sole prerogative of the Government of Dubai / DNRD and we cannot influence same under any circumstances.

- 5. Copy of Visa of Onward destination (Mandatory for Visa Codes EK48, ALL48, ALL96) if not eligible for "Visa On Arrival".
- 6. Profession of Applicant (Proof is not required)
- 7. If married and traveling with Spouse but name of spouse not mentioned in any of the passport then Copy of Marriage Certificate or any other proof if recently married during applying visa.

Mandatory Documents Required for 30 Days Stay Single/Multiple Entry Tourist Visa:

(Visa Code: - EK30S, EK30M, ALL30S-DS, ALL30-ADS, ALL30M)

- 1. Coloured Copy of Passport in JPEG (valid for over 6 months at the time of arrival in UAE)
 - Bio Data Pages of Applicant's passport (Pages having photo and address)
 - Pages having any observation
- 2. Good Quality White background photo in JPEG (Photo must not be very old)
- 3. Copy of PAN Card of Primary Applicant
- 4. Confirmed Ticket (Mandatory for Visa Code EK30S, EK30M and OTB)
- 5. Profession of Applicant (Proof is not mandatory)
- 6. If married and traveling with Spouse but name of spouse not mentioned in any of the passport then Copy of Marriage Certificate or any other proof if recently married during applying visa.

Remark: - Additional supporting documents may be asked based on profile of applicant

 - Bio Data Pages of Applicant's passport (Pages having photo and address)
 - Pages having any observation
- 2. Good Quality White background photo in JPEG (Photo must not be very old)
- 3. Copy of PAN Card of Primary Applicant
- 4. Confirmed Ticket (Mandatory for Visa Code EK90S, EK90M and OTB)
- 5. If married and traveling with Spouse but name of spouse not mentioned in any of the passport then Copy of Marriage Certificate or any other proof if recently married during applying visa.
- 6. Any Evidence of Employment

Additional Supporting Documents for 90 Days Stay Single/Multiple Entry:

(Mandatory for Visa Codes: EK90S, EK90M & ALL90M)

- 1. A Covering letter mentioning the reason of travel, stay & host details and self-guarantee of exiting Dubai within the visa validity period. Two (02) local contact details (who stays in different address) shall also needs to be mentioned in the same letter and supported by their Photo id cum Address proof.
- 2. If Purpose is Business and Invited by a company based in UAE then Copy of Invitation Letter
- 3. If Purpose is visiting friend or relative then Copy of Invitation Letter along with UAE Residence permit of Host
- 4. If Purpose is Tourist then (Any One) :- Only for Primary Applicant
 - A Guarantee Letter from Employer along with pay slips for last 3 months
 - Proof of Travel Record if travelled at least once in the last 5 years to or has a valid visa for countries like USA, UK, Schengen countries, European Union, Australia, New Zealand, Russia, Canada, Switzerland and Japan or have evidence of travel records in the last five (5) years to the UAE
 - Last 2 Years Form 16 or last 2 Years Income Tax return with a minimum gross income from business, profession or employment, which should exceed INR 2 lakhs Per
 - Proof of Investments amounting to INR 5 Lakhs or above, in form of fixed deposits in Banks or Post Office. (Investments to be a year prior from the date of application with a validity of more than 12 months, Investments in Co-operative Banks or Societies are not acceptable)

Remark: - Additional supporting documents may be asked based on profile of applicant
