

## EVISA FOR UKRAINE

<b>Processing Time from Date of Lodgment of Visa Application for Indian Passport</b>	
Regular (Normal) Mode	Minimum 5 working days
Express (Urgent) Mode	Minimum 2 working days
<b>Non-Refundable Visa Charges Payable for Indian Passport</b>	
Normal Single Entry	INR 2000 + Service Charge
Urgent Single Entry	INR 4000 + Service Charge
Normal Double Entry	INR 2700 + Service Charge
Urgent Double Entry	INR 5400 + Service Charge
eVisa validity	e-Visas are issued as single or double entry visas valid for up to 30 days. All applicants should submit their printed e-Visas (along with their valid travel documents) to Ukraine's State Border Guard Service officers when entering Ukraine. ***The decision to grant or refuse a visa is the sole prerogative of the respective Visa Office and we cannot influence same under any circumstances***

**Ukrainian eVisa is available for following categories: -**

1. Business Visit
2. Tourism
3. Private Visit
4. Medical Treatment
5. Cultural, Scientific, Educational and Sports Activities
6. Mass Media Staff

For entry into and exit from the territory of Ukraine you shall present e-Visa printed hard copy along with passport document to the Ukraine`s State Border Guard authorities and shall keep it for the whole period of stay in Ukraine.

The mere fact that you have been granted an e-Visa does not mean that you are entitled to compensation if you have breached the provisions of the Ukrainian legislation and therefore have been denied entry to Ukraine. **Your compliance with entry requirements will be checked again at the border control, including:**

- a confirmation of the purpose of the intended stay;
- a demonstration of a valid medical insurance policy with coverage of at least 30000 Euro or its equivalent in other currency;
- a demonstration of sufficient funds to cover the costs of an intended stay in Ukraine and return to the state of origin, or ability to legally acquire sufficient funds in the territory of Ukraine.

## **List of documents required for eVisa to enter Ukraine**

### **Common Documents: - All Visa Types**

1. Colored Scan Copies (Printer Scan) of Passport (Bio Page and Address Page)
2. Good Quality White Background Photo (Face Visibility 70 to 75%)
3. A Valid medical insurance policy with coverage of at least 30000 Euro or its equivalent in other currency and with COVID coverage
4. Applicant's Contact Number to mention in Visa application
5. Visa request letter addressed to "Ministry of Foreign Affairs of Ukraine" stating purpose of visit, duration, etc
6. **The documents confirming the availability of sufficient funds: - Any One**
  - a) a document confirming the booking or payment for housing and food in Ukraine
  - b) an arranged tour services contract (voucher);
  - c) a guarantor's letter from the host party inviting the foreigner, where host party undertakes the obligations to pay all the expenses related to the foreigner's stay on the territory of Ukraine and departure abroad
  - d) a fixed date ticket for return to the state of nationality or to the state of permanent residence or to the third state.
  - e) Bank Statement with sufficient funds (recommended with any of the above docs)

### **Additional Documents for Business Visit: - Any One**

- a) A letter of invitation from a legal entity registered in Ukraine, presented on the official letterhead, containing the number assigned in the Unified State Register of Legal Entities, Individual Entrepreneurs and Public Organizations, registration number, date and signature, full name of the invited person, information about his/her date and place of birth, nationality, passport document details, place of residence, purpose of visit, duration of intended visit to Ukraine, number of entries and place of residence in Ukraine, the commitments of the legal entity on payment of the possible costs relating to the invited person's stay in or exit from the territory of Ukraine;
- b) A letter of invitation from state authority, state institution, state enterprise, state organization;
- c) A document confirming foreign investment according to the legislation on foreign investment regime in the territory of Ukraine

***Additional documents or information may be asked during submission***

**Additional Documents for Private Visit: -**

- a) a notarised invitation from a natural person - a citizen of Ukraine or a foreigner, or a stateless person legally residing temporarily or permanently in Ukraine. The invitation must include the surname, name, patronymic of a natural person, details of their passport and permanent or temporary residence permit (for foreigners and stateless persons), address, as well as surname, name, patronymic of the invited person, information about their date and place of birth, citizenship, passport details, their place of residence, purpose of the trip, period of the planned visit to Ukraine, number of entries and place of residence in Ukraine, the obligation of the natural person to bear all the possible costs associated with the stay and departure of the invited person from Ukraine. Passport copies and certificates of temporary or permanent residence permit (for foreigners and stateless persons) in Ukraine of the host party (a natural person) must be attached to the invitation
- b) a document confirming foreigner's real estate ownership in Ukraine (if applicable)
- c) documentary evidence that the foreigner is a husband, wife, father, mother or a child of Ukraine's citizen (if visiting family member)

**Additional Documents for Tourist Visit: - Any One**

- a) a document confirming hotel reservation
- b) an arranged tour services contract (voucher),
- c) a document confirming the receipt of tourist services in Ukraine regarding arranged visits to cultural facilities, recreation, etc

**Additional Documents for Medical Treatment Visit: -**

- a) a document confirming hotel reservation invitation letter issued by Ukraine's hospital/medical treatment institution.

**Additional Documents for Mass Media's purpose of Visit: -**

- a) a letter of the foreign Mass Media with a request to issue a visa to the foreign correspondent/Mass Media staff member who intends to travel to Ukraine in his/her professional capacity;

***Additional documents or information may be asked during submission***

**Additional Documents for Cultural, Scientific, Educational and Sport's purposes of visit: - Any One**

- a) an invitation from a legal entity registered in Ukraine provided on an official form. The invitation must contain the number from the Ukraine's State Register of legal entities, private entrepreneurs and public associations, the registration number, date and signature, last name, first name, patronymic of the invited person, information about their date and place of birth, citizenship, passport details, place of residence, purpose of the trip, period of the planned visit to Ukraine, number of entries and place of residence in Ukraine, the obligation of the legal entity to bear all possible costs associated with the stay and departure of the invited person from Ukraine
- b) a letter of invitation from state authority, state institution, state enterprise, state organization.
- c) a letter of request from state authority of a foreign state or international organization.
